



# **Were The Pearl Harbor Commanders** Accorded "Due Process" Under the "Bill of Rights?"

The Fifth Article in a Series Comprising Research Dealing With the Pearl Harbor Disaster

Editor's Note: Martin Merson, a native Virginian, is a graduate of Annapolis, Class of 1928, a veteran of the Pacific War, and a retired federal administrator. During WWII he served aboard a cruiser in combat and while serving as Executive Officer, Advanced Naval Base, Guadalcanal, British Solomon Islands in 1942, was seriously disabled. Merson holds a Juris Doctor degree from Harvard University and a Ph. D. in Political Science from the University of North Carolina, Chapel Hill. He served in the Eisenhower Administration's State Department, described in his book The Private Diary of a Public Servant, MacMillan, 1955. Merson has also taught international relations at the university level.

hroughout the past 10 years during which this writer has dug deeply into the available material concerning the Pearl Harbor disaster, it has always been assumed that those of us privileged to serve in the military forces of the United States have the same rights to due process as do any and all

As the basis for considering the full implications of due process, the first four articles published under the name of this writer are summarized herein, as follows:

I - In the Navy Times of December 1988 we learned that the Pearl Harbor Survivors Association - 10,000 strong -would commemorate the 45th Anniversary of the attack by holding a reunion in Hawaii at which copies of resolutions and medals were being presented to the families of Admiral Kimmel and General Short having the effect of honoring Admiral Kimmel and General Short with an expression of admiration and respect.

It should be emphasized that no rank is recognized by the membership of this Organization and thus we have no way of knowing whether or not it was enlisted personnel - rather than officers - who took the lead in pushing for a too long delayed honor to the Pearl Harbor Comanders. It is only fair to ask whether the men and women: soldiers, sailors, marines, nurses and others who laid their lives on the line that fateful day nearly fifty years ago are sending a message to those who are at the helm of government today - in and out of uniform - to bestir themselves and rectify gross injustices to Admiral Kimmel and General Short?

II - In Officer Review magazine (The Military Order of the World Wars) the Memoirs of Admiral James O. Richardson were reviewed. Interestingly, these Memoirs of the United States Fleet Commander, immediately preceeding immediately preceeding Admiral Kimmel, although completed in 1958, did not see the light of day until 1973. The reason for the delay of a book filled with vital information has by no means been made clear. During this protracted delay many books were published which might well have been otherwise challenged by the Richardson book. It is significant that James O. Richardson's career elevation to the Navy's highest post at sea: Commander-In-Chief, United States Fleet, was initiated by the first term election of Franklin Delano Roosevelt to the Presidency; it would not be amiss to suggest that Richardson was FDR's man at the Navy's helm. Why then did FDR fire Richardson after only one year in what was normally a two year assignment? The answer is plain.

Richardson in clear and unequivocal terms told FDR that the Fleet was not ready for war and that Pearl Harbor was by no means an ideal place to station the Fleet in the event of war with Japan. There is much that is significant in the Richardson Memoirs and copies of this article will be made available to those who have not already read it.

III - The third article was published in Volume Eight, Number Two, Summer 1988, The Journal of Historical Review. Richardson thoroughly grounded in the War Plans pointed out to Admiral Harold R. Stark, then serving as Chief of Naval Operations, how unrealistic were the War Plans under which Richardson would act if war should ensue. Basically, there was no "Train" i.e. the auxiliaries so vital to moving combatant ships long distances from the home base. A careful reading of the Memoirs discloses that Richardson, thoroughly grounded as he was in the use of a Fleet in times of war, was raising questions with responsible authorities in Washington which those authorities were not prepared to answer but the straw which broke the camel's back came when the forth-right Richardson told FDR face to face that the Fleet should be pulled back to the

West Coast and offered no deterrence to the Japanese, contrary to FDR's expressed reason for keeping the Fleet at Pearl.

The third article adds much background material, including the fact that the Chief of Naval Operations told Richardson to desist from long range air reconnaisance.

IV - The fourth article, entitled: The Scapegoats of Pearl Harbor; J'Accuse Revisited, begins with an allusion to the fact that:

... there took place in France in the late 19th century an event which is in many respects on all fours with the Pearl Harbor Affair. In fact one of the more recent books on France's convulsive struggle with the case of Alfred Dreyfus is entitled The Affair. Then, a rather colorless French Army Officer, Alfred Dreyfus, attached to the French General Staff was accused of selling secrets to the Germans. Tried, and convicted by military court martial in 1894 - on the basis of evidence withheld from the Defense -Dreyfus was sent to Devil's Island for life. Two years later the French Intelligence Service found that the leaking of secrets to the German Embassy continued, and identified a French Army Major, Esterhazy. Indications were that Esterhazy might well have been the original seller for which Dreyfus was blamed.

One has to wonder whether military High Commands have changed much over the years in terms of displaying a passionate regard for their own loyal officers' civil rights. In the case of France, the High Command refused to permit a reopening of the Dreyfus case on the grounds that it might create doubts about the Army's rectitude and thus endanger National Security. This concern went so far as to permit the Intelligence Branch to manufacture false evidence, to preclude public pressure to retry Dreyfus. This was carried to the extreme of carefully orchestrating the court martial of Esterhazy and acquitting him. It was at this point that Emile Zola issued his memorable manifesto: J'Accuse (13 January 1898) which stirred France to its roots. In fact the Columbia University History of the World describes the period as one in which the Country was again split apart '... a resurgence of the old republican anticlericalism' - wounds were reopened which had lain festering for a century - climaxed by the final clearance of Dreyfus by the civil courts - some twelve years after the original conviction - and restoration to his place in the Army."

#### Is There Bias And Prejudice Among American Historians: If So Does It Affect The Writing Of American History?

The late Thomas Andrew Bailey of Stanford University, former head, Department of American History, and the-reafter Emeritus Professor wrote a book entitled: Presidential Greatness: The Image and the Man From George Washington To The Present; Appleton-Century-Crofts, New York, 1966. In Chapter III, Bailey discusses the polls conducted by the late Arthur M. Schlesinger, Sr., of Harvard University, excerpt follows:

The first came in 1948; the second in 1962. The first solicited the views of fifty-five experts; the second, employing the same techniques, solicited the views of seventy-five experts, who included most of the original fifty-five. Of the seventy-five, fifty-eight were professional historians, six were political scientists, three were historians and political scientists, two were journalists, and the remainder represented scattered callings. Felix Frankfurter, a long time friend of Dr. Schlesinger, was a justice of the Supreme Court. Commendable, the polls attempted to provide a geographical cross section of the country, and to attain even greater objectivity by seeking the opinions of three Britishers, including the well-informed Denis W. Brogan.

What Doctor Bailey sought to determine is just how objective were the scholars he probed. He concludes:

The truth is that an overwhelming majority of those who teach American history in our colleges and universities are Democrats, and one should not be surprised to find this bias among the Schlesinger pollees. Their generally low grading of Republican Presidents was perhaps not so much an indictment of the men themselves as it was of the Republican philosophy, namely, that the Chief Executive must be an executor or caretaker of the rather passive type, rather than a strong activist or reformer of the type attractive to Democratic liberals.

... the heavy representation of Harvard University on this list is not strange. With its topflight faculty and other splendid facilities for graduate work, it attracts and hence trains a disproportionate number of brilliant young minds.

coloration of the two groups probably accounts in part for the pro-Democratic slant. The American Historians on the Harvard faculty, as is generally true in other leading Universities, are overwhelmingly of a liberal or liberal-Democratic persuasion, and have been for many years.

These polls provoked widespread comment and considerable dissent. For example:

"The foes of Franklin Roosevelt objected bitterly to his being placed above Wilson, Jefferson, and Jackson and only slightly below Washington, the great father image."

Intrigued by his findings, Dr. Bailey states:

As a kind of follow-up to the Schlesinger poll, I conducted

an informal poll of my own. I made contact with friends or acquaintances in the history departments of some thirty leading universities, either personally or by letter. I asked whether a majority of the instructors teaching American history in these institutions were Democrats or Republicans. With the exception of one evenly balanced department and one pro-Republican department, in every instance a clear majority of the teachers presenting American history was Democratic. In many cases the majority was overwhelming; in several cases the group was unanimously democratic. Even where the members were Republicans they inclined to be liberals and to favor Hamiltonian means to achieve Jefferson ends.

# "Infamy: The Gathering Storm"

Symposium Admiral Nimitz Museum, May 9-12, 1991

The fourth in the symposium series on World War II in the Pacific topics is set for May 9-12 next year for the Admiral Nimitz Museum of Fredericksburg, Texas, the Admiral's home town. Museum Director Bruce Smith announced this week that the formal sessions of the Pearl Harbor Symposium will be held Thurdsay and Friday, May 9 & 10 at the Performing Arts Center on the University of Texas Campus in Austin. "We were forced to look beyond Fredericksburg for the Pearl Harbor attack symposium," said Smith, "due to the increased number of people who wanted to attend the programs." The second part will take place in Honolulu the week following December 7th, 1991 and will be hosted by the USS Arizona Memorial and assisted by the Admiral Nimitz Museum. Those sessions will deal with the attack itself and its legacy.

An air show is being

planned for the final day of the symposium weekend which could be the largest staging of the Pearl Harbor attack since the Tora Tora Tora film in 1970. Negotiations are currently underway with the Confederate Air Force which has supported the museum in the symposium series twice before.

"We are planning to take a fresh look at some interesting and potentially controversial topics," said Smith, "but we hope we can add a footnote to history and a better understanding of just how the attack came about and maybe address the question of why as well." Reservations for the symposium will be taken starting in December, but those interested may write to be put on a list of those to be personally contacted. 

**Target: Pearl Harbor** 

By Michael Slackman. Published by University of Hawaii Press and Arizona Memorial Museum Association.

An interesting view of the Pearl Harbor attack as seen through the eyes of the participants. On the American side were individuals so secure in their dismissal of Japan as a third-rate power that even as destruction rained down they could hardly believe the planes they saw were Japanese.

For the Japanese, the months of planning and the tense and silent voyage were finally over. The attack was an exhilerating beginning for their ambitious plans of conquest.

The book is enriched with stories and anecdotes from over a hundred interviews and from the holding of oral history programs.

It made me feel that I was watching each of the men in action and it told me much more about some of the medal winners, more that just what I have read in citations.

# **Pearl Harbor Survivors Dedicate Tree Memorial**

Joe Nemish's dream of a living memorial dedicated to the men who were killed during the Pearl Harbor invasion came true last week.

The first of 2,500 digger pine trees was planted on a 160-acre site in Keysville, September 1, during a public ceremony sonsored by Nemish and his group, the Pearl Harbor Survivors.

The morning ceremony culminated more than a year-long effort for the Lake Isabella resident to establish a living memorial where one tree would be planted for the estimated 2,500 men killed on December 7, 1941 when the Japanese attacked Pearl Harbor.

Nemish said credit for the memorial wasn't his exclusively and was quick to add that he had a lot of assistance.

"This project took the combined effort of many people. It was through their cooperative attitude and generous spirit that this was all made possible," Nemish said.

The Bureau of Land Management donated the 160 acres of land for the memorial.

Glen Carpenter, area manager with the Bureau said he was skeptical when first approached by Nemish.

"Joe came to us with his idea. I told him right away that it was a good idea, but there would be a lot of bureaucratic red tape in the way," Carpenter said. "But he tackled each obstacle and for that I applaud him."

The acreage donated for the living memorial reflects scars of misuse by the public — primarily those caused by off-highway vehicles.

(Note: The National President of the Sons and Daughters of Pearl Harbor Survivors, Andrew Shumberger, flew in from Albuquerque, New Mexico to attend the ceremony.)

#### 1. Pearl Harbor Survivors Association Fiftieth Anniversary **History Book**

President Creese introduced Mr. Dave Turner of Turner Publishing Co., P.O. Box 3101 in Paducah, KY., 42002-3101. Mr. Turner has submitted a proposal to compile and publish for sale, a book of the 50th Reunion in the form of a history. The book is to be hard bound and will sell for \$48.00 with a 5% royalty to accure to the PHSA Inc from sales. A copy of the proposal is attached as a permanent part of thsi record of minutes. It was made clear that there would be no financial responsibility to the PHSA Inc

It was concluded after discussion that our Roster of Names would not be furnished the publisher. Rather, the control would remain with the PHSA Inc to provide labels for the sales ordered and at the publisher's expense.

#### 2. Pearl Harbor Survivors Association Photogrophy and Video.

President Creese introduced Mr. Mark Richman of Photogropher Video, 1-800-833-4686. Mr. Richman wants to photograph and provide for sale, the largest picture in the world of the group of everyone attending the 50th Reunion in 1991. He has contacted the Guinness Book of Records prople and expects an interest from them for entry in their book of record. Additionally, there will be smaller and more manageable prints and be guarantees that everyone will be recognizable.

He is offering, also, pictures of various groups who will be holding gatherings and reunions with special interest to the events that will take place marking the 50th reunion.

Royalty or profit to the PHSA Inc from sales was not mentioned at this presentation.

It was concluded after discussion that the same rule of providing the Roster of Names as stated in para. 1. of these Minutes will govern. Bill Eckel suggested that a performance bond be required. The problem of payment for a product, subsequent non-delivery without refund of the purchase price that plagued the 1986 Convention Video's offering must not be permitted to recur. Moreover, the fear by Members of a similar scam may hinder sales.

#### Not discussed at the EB Meeting

Secretary McClintock suggests for consideration, a plan, that, with or without bond for the vendors would protect our Members and any others who desire to purchase the books or the

'A Survivor be appointed to handle all orders and money. Orders for the books or photographs be submitted to the PHSA Inc in duplicate (original and 1 copy) with the check to cover the order made out to PHSA Inc Book or Photo.

PHSA Inc will deposit the check in a separate account and send the original order to the Book Publisher and/or Photographer. PHSA Inc will file the copy of the order as record. The publisher and/or photographer will drop-ship the product upon receipt of the order. When the purchaser has received the product and is satisfied, notification will be given to PHSA Inc and the check for the amount of the purchase will be sent to the publisher and/or photographer. The check will be less any royalties or just dues accruing to PHSA Inc. PHSA Inc will make final accounting and transfer the proper funds to the PHSA Inc Treasurer periodically.

#### 3. Clark O. Martin's letter to Ken Creese regarding the Financial Statement.

President Creese read a letter from Clark O. Martin, 103 Santa Clara Drive, Richmond, VA., 23229 dated July 17, 1990 wherein Martin had expressed objections to the Pearl Harbor Survivors Association Inc Financial Statement and the Independent Auditor's Report of September 30, 1989.

The Resolutions contained in this GRAM are to be acted on at the National Convention in Albuquerque, NM, in December, 1990. The pages have been perforated for easy removal. Be sure to take these Resolutions with you to the National Convention.

Resolution No. 1 Subject: Provision for Universal Voting for All PHSA Members

WHEREAS: It is in the best interests of PHSA that the voice of all members be heard in decisions affecting the Association.

WHEREAS: Participation in official business at National Conventions has become more and more restricted to members having the finances, good health, and opportunity to attend, which group has effectively dwindled such that less than 2% of the membership is now conducting national PHSA affairs.

WHEREAS: Current voting procedures are unhealthy and divisive, pitting North vs South, large vs small, etc.,

WHEREAS: In Keeping with our times, it is moral to provide all members a voice, (not to so provide is to deny a voice, violating PHSA objectives).

BE IT RESOLVED that Art. VIII.1, NA By-Laws shall be deleted in its entirety.

In it stead shall be inserted as follows:

Art. VIII.1. Voting on election of all National Officers, and on all items of business at the National Convention, except for designated emergency measures, shall be by mailed ballots. Candidates and measures which receive the greatest number of votes shall be declared successful.

Arts. VIII.2 and VIII.3 shall remain, and as numbered.

The National Executive Board shall establish procedures and timing guidelines similar to NA 19.12, by which the foregoing can be effected, utilizing existing Local, State and National Officers and structures; and provide a ballot on which all PHSA members in good standing who wish to do so may vote.

Resolution No. 4 Subject: A Remembrance Prayer for Pearl Harbor Day, 1991

WHEREAS: On this day 50 years ago, the attack on Pearl Harbor drew the United States into a conflict that claimed more than 400,000 American lives.

WHEREAS: Almighty God granted us final victory, and enabled us to become friends with our former enemies.

THEREFORE: We, survirors of the attack on Pearl Harbor, petition the Senate and House of Representatives of the United States, all legislative bodies of its several states, and all churches and synagogues in the United States, to join in the following or like prayer of remembrance at some appropriate time near December 7, 1991.

"God of the ages, in your sight nations rise and fall, and pass through times of peril. On this day we remember with gratitude those who died in defense of Pearl Harbor on Dec. 7, 1941, and all those who gave their lives in this nation's defense during the ensuing conflict. Hasten the day when there will be no more war, and all your children will learn to live together as brothers and sisters. For your own Name's sake. Amen."

Resolution No. 5 Subject: Revise Art. XII of Nat. Constitution. "Quorum at National Convention" to allow delegates to vote for chapter, ets.

WHEREAS: Due to a variety of valid reasons, many PHSA members are unable to attend State, District or National Conventions.

WHEREAS: Members who are unable to attend such Conventions are disenfranchised from voting on matters of importance to them.

THEREFORE: Be it resolved that Article XII of the Constitution, Quorum at National Convention, be revised to read as follows:

Quorum at National, District and State Conventions. Each Chapter shall elect and certify a delegate and an alternate delegate. The delegate or, in the delegate's absence, the alternate delegate shall vote on the transaction of business for the PHSA, Inc. Each delegate, or alternate shall cast one vote for each 10, or fraction thereof, Chapter members. delegate Chapter members, in good standing, attending Conventions shall be entitled to vote separately from the delegate or alternate delegate and have their vote counted as 1/10 of a vote. A majority of the votes cast at a Conventions shall constitute a Quorum.

Resolution No. 6 Subject: A resolution to restore the full wartime rank of Adm. Kimmel and Gen. Short (posthumously).

WHEREAS: Following the

surprise Japanese attack on Pearl Harbor December 7, 1941 the two officers in command of U.S. armed forces at Pearl Harbor, Admiral Husband E. Kimmel (Pacific Fleet Commander) and Lieutenant General Walter C. Short (Hawaii Army Commander) were retired in "permanent grade" from their respective branches of the armed forces.

WHEREAS: At the time of the attack Admiral Kimmel was serving in a temporary appointment as full Admiral (four stars) but was retired as Rear Admiral (two stars), his permanent grade.

WHEREAS: At the time of the attack, Lieutenant General Short was serving in temporary appointment as Lieutenant General (three stars) but was retired as a Major General (two stars), his permanent grade.

WHEREAS: In 1947 provisions were enacted in the laws governing retirement from the armed forces which permitted officers who had temporarliy served in a higher rank to be advanced on the retired list to that higher rank, without benefit of higher pay, when recommended for such advancement by the Secretary of Defense and approved by the President of the United States and concurred in by the Senate.

WHEREAS: Recently published historical writings (see cover story in this *GRAM*) and film documentaries established that Admiral Kimmel and General Short were unjustly made scapegoats for the success of the surprise attack on Pearl Harbor and other military installations on Oahu on December 7, 1941.

WHEREAS: At its National Convention in December 1984 at Grossingers Resort in New York State, the Pearl Harbor Survivors Association, representing voices of the time, unanimously passed a resolution honoring the memory of Admiral Kimmel and General Short and praising them for having single-handedly shouldered the full blame for the disaster at Pearl Harbor when, in fact, others, and the whole nation should have shared the burden.

WHEREAS: The terms of the 1984 resolution were ful-Continued on Page 22

filled at the PHSA 45th reunion in Hawaii in December, 1986 when these officers' nearest living next-of-kin were presented beautifully inscribed plaques honoring Admiral Kimmel and General Short with an expression of admiration and respect.

#### RESOLVED:

(1) That the Pearl Harbor Survivors Association urges the Secretary of Defense to recommend to the President of the United States that he nominate Rear Admiral Husband E. Kimmel (Retired) (Deceased) for posthumous promotion to the rank of full Admiral on the list of retired naval officers and Major General Walter C. Short (Retired) (Deceased) for posthumous promotion to the rank of Lieutenant General on the list of retired army officers, these ranks being the highest in which these officers served while on active duty in the armed forces of the United States in 1941

(2) That the Pearl Harbor Survivors Association urges the President of the United States to make the aforedescribed nominations and send them to the Senate of the United States for its advice and consent with the recommendation that they be favorably acted upon by that body.

(3) That the Pearl Harbor Survivors Association urges the Senate of the United States to give its advice and consent to the aforementioned nominations.

#### RESOLVED FURTHER:

(4) That the Secretary of the Pearl Harbor Survivors Association forward copies of these resolutions to the Secretary of Defense, the President of the United States, the Secretary of the U.S. Senate, and to the Chairman and each member of the Senate Armed Forces Committee.





Five Deming residents recently received their Pearl Harbor survivor license plates following state legislative action authorizing them for the first time in New Mexico.

"You have to be a certified survivor of the Dec. 7, 1941, Japanese attack on Pearl Harbor to receive one of the plates," said Harvey Stanford, a second class U.S. Navy fireman on the U.S.S. Raleigh during the attack.

Survivors wanting to purchase the special plates are checked out thoroughly first. They pay a regular registration fee and are issued one plate which can not be transferred to anyone else. It will be replaced

in case of loss or mutilation, said Stanford, secretarytreasurer of the local survivors association chapter.

There are five known Pearl Harbor survivors in Deming, all members of the Chapter 2 Roadrunner Pearl Harbor Survivors Association of Southern New Mexico. The organization's five members get together once a month and go out to eat at a restaurant.

"We tell sea stories," said Stephen DuBois. "There aren't many of us around anymore, we're thinning out." DuBois was a second class Navy Hospital corpsman attached to the 4th Defense Battalion Fleet Marine Force.

## When Hollywood Heroes Went to War

The Japanese sneak attack on Pearl Harbor on December 7, 1941 turned a sleeping America into a determined nation of heroes. And it was soon to be Hollywood's finest hour. Screen stars by the hundreds put away their lucrative, glamorous careers to defend their country. Everyone helped in his own way. Cecil B. DeMille became an air-raid warden. Hollywood's most famous actress, Carol Lombard, died in a plane crash in 1942 while she was on a bond-selling tour. In the months that followed the attack, Victor Mature, Mickey Rooney, Raymond Massey, Gene Autry, Lew Ayres, Broderick Crawford and Rudy Vallee were in uniform. Before it was over, nearly every name in Hollywood was in the fray: Robert Montgomery, Tyrone Power, Coogan, William Jackie Holden and Burgess Meredith.

One of the first to enlist was Jimmy Stewart. The legendary star flew 20 missions over Europe as commander of a bomber squadron in the U.S. Army's Eighth Air Force. He is the only actor ever to achieve the rank of brigadier general. Clark Gable threw himself into the war effort following the death of wife Carol Lombard. Refusing a soft public relations job, the king of Hollywood volunteered for combat and

flew numerous missions over Europe. Glen Ford performed his heroics in the Marines, where he rose through the ranks to colonel. He battled with the French Foreign Legion, and is the only American actor ever awarded France's Legion of Honor.

Henry Fonda, called the "sythesis of all heroes" by director Joshua Logan, enlisted as a seaman. He was discharged as a full Navy lieutenant, after winning the Bronze Star and a Presidential Citation. James Arness was downed by German machine gunners while assaulting Anzio Beach and permanently injured his hip. Charlton Heston brought to the service his rugged strength and forceful energy, serving in the Pacific as a radio operator aboard a B-29. Robert Stack took his skill on the shooting range to the Navy. He held the world skeet shooting record from 1936 to 1937. "It helped erase the stigma of being an actor in the eyes of other GI's," Stack said. One of the men Stack trained was Paul Newman.

Those unable to fight helped make training films or morale-building movies. John Wayne became a hero portraying military men in films like "The Sand of Iwo Jima." Hollywood, realizing the value or such films, ground out movies to

"rally 'round the flag" in the hundreds. Entertainers like Bob Hope took their acts to the front to cheer the troops. It was a special time for Hollywood, a time when the gods of the cinema proved there were real men behind the screen images.



In addition to the label spot checks the computer will, for the issue due in November, count the Life Members and figure the percentage of the overall count these comprise. A check will also be made of the zip code areas where there was a reported failure of delivery. Although many non-deliveries have been explained by members not being at the address they have reported, it does not explain why those who have never been away have been missed.

Further discussion revealed that a resolution was being submitted to Convention to add a charge of \$5.00 to all members to defray the cost of First Class postage for the Gram. Jerry Glaubitz read the resolution and explained the need for such a rule. Many of the non-deliveries could be avoided for those who are temporarily away and overstay the period the post office will forward and deliver 3rd Class mail.

President Creese agreed to check the post office in San Bernardino to see if they can lend a hand in solving the problem. Remember . . . lst class mail always is forwarded.

#### 7. AmVets request to join 50th Parade

President Creese reported that he had received a letter from the AmVets requesting that they be permitted to parade with us at that 50th Reunion. They also asked to be kept at low key and out of our way so as not to interfere with our celebration.

Joe Nimitz will be notified in order that he can coordinate the affair in Honolulu. Chuck Mallon is to coordinate Mainland inputs to Joe.

We are trying to get the 50 States Flags to march with us along with three Military marching bands. Reasonable assurance has been given that none of the problems of cancellation and unscheduling will take place at the 50th.

# 8. Registration Fee. Why do children have to pay for the cocktail party when they don't drink??

This question came from Curt Schulze because he had received it from members of his District.

A letter from the Treasurer to the President outlined a change in the registration fee charge because of objection of some of the members. The Treasurer had discussed the problem with the Secretary but no clear cut change had been suggested except that which appeared in Bill's letter.

Tendency is toward an independent company hired and run by PHSA Inc. with schedule arrivals and departures provided by close watch on airlines. We can do this cheaper but the coordination is the problem.

Although American Airlines has the contract for air transportation, they must compete with those Survivors who will take another airline because of cost.

#### 10. Foundation

At the request of President Creese, Al Fickel, Texas State Chairman, went to the capital and checked on the record for the Foundation and found none. It appears that there is no record of the establishment of the Foundation. The only record found was for the PHSA of Texas Inc. Fickel will make another check. Wally Kampney reported that IRS had assigned a tax number to the Foundation. It was argued that the IRS number did not mean a working organization was indicated.

# **Hooked on Helping Children**

Ralph Moore isn't a doctor, but hundreds of central Indiana children might have trouble getting much-needed medical attention without his help.

Moore, who lives in Indianapolis, arranges free transportation for children from Marion and several surrounding counties to three Shriners hospitals in this part of the Midwest.

Moore, 75, an Olivetti Corp. retiree, is transportation coordinator for the Murat Shrine's Transportation Club.

The group exists solely to take children to and from the hospitals and to provide transportation for visiting Shrine dignitaries during special events.

He says his hospital-related work takes three or four hours a day. He matches patients' appointment times with schedules of drivers from a pool of about 40 Shriner volunteers, most of whom are retirees, too.

Murat Temple provides the vehicles - two Ford Econoline vans, one equipped to transport patients in wheelchairs.

Moore also is responsible for having the vans repaired - he depends on the drivers to tell him about problems - and maintained.

He wife, Evalyn, helps him, he says, by working as a combination secretary and answering service. She says he sometimes gets emergency calls at 3 a.m.

The number of patients with whom Moore works has grown steadily in the eight years since he first volunteered to do the job.

In 1989, Moore arranged 248 van trips that carried 426 patients to either the Shriners Burns Institute in Cincinnati or to either the Chicago or Lexington, Ky., Shriners Hospital for Crippled Children.

Moore first became involved when the former transportation coordinator died and the president of the club asked for a volunteer, "just to help out for the rest of the year. This was, like, in October - and I'm still doing it," Moore says.

For several years, Moore, a veteran of the U.S. Navy, was Indiana state chairman of the Pearl Harbor Survivors Association. He was aboard the USS Sacramento when the harbor was attacked.

He says the chairmanship of the survivors' organization took too much of his time, so he gave it up.

But he has continued his Shrine work, he says, because "you get hooked on it. You want to help keep the program going." Probably the biggest reward is when you see a kid that couldn't walk. After four or five years, with the help of operations and maybe, braces the kid's up walking around."

The Shrine of North America, Moore says, has built a network of 22 hospitals – 19 orthopaedic facilities and three burn centers – scattered throughout the United States, Canada and Mexico.

All provide free treatment for children until their 18th birthdays.

Moore says his loyalty to the Shrine is one of his motivations for spending so much time as transportation coordinator.

"The Shrine program - the philanthropy - has just grown and grown and grown.

"But the children, more than anything else, keep me hooked on it."

a vague indictment whose allegations were never to meet the test of trial.

In the days immediately following the attack the public was led to believe that court martial proceedings were ultimately to be commenced. However, the war time emergency and public absorption with the crucial tides of battle were advanced as continuing pretexts for not instituting them. Thus matters stood as of December 7, 1943 two years after the attack.

Pursuing the Kimmel/ Short case to the present day, it will be clear that the two officers were never to undergo a formal trial of any kind whatsoever. In this respect their "due process" was unlike that of a common criminal charged with the most heinous crime imaginable. Throughout the Nation there are "death rows" filled with criminals who have had one or more formal trials, and who are likely to have one or more additional trials prior to execution, if any.

Admiral Kimmel's Story did not receive wide spread publicity published by a small book publisher, it is doubtful that many of us were ever made familiar with the book: obviously it could not and did not under the circumstances make the New York Times Book Review Best Seller list. However it is of interest that one of the most outstanding Naval Strategists - since the days of Alfred Thayer Mahan - a graduate of the Naval War College, W.D. Puleston, Captain, USN Retired did review Admiral Kimmel's Story in the Annals, Volume 300, July 1955 at page 139. We furnish excerpts from the Puleston review:

Kimmel's story told in terse language is as dramatic as any Greek tragedy. Unexpectedly summoned to command our most powerful fleet he dili-

gently prepared it for its assigned tasks in the event of war, simultaneously striving to insure its security in case of a Japanese surprise attack. Unjustly sacrificed with Short to shield the short-comings of the President and "High Command" in Washington, who as Stimson has revealed sought to entice Japan into striking the first blow where it would do little injury, he patriotically remained silent, only regretting that he had not foreseen 'what happened on December 7'.

The Army Board held that General Marshall had withheld vital information from General Short, the Navy Court charged Stark with depriving 'Kimmel of the clear picture of the existing situation'; it cleared Kimmel of the accusation made by the Roberts Commission of failing to cooperate with Short. Most important it approved his measures for preparing the fleet for war, while taking all feasible means of insuring its security during a surprise attack.

Stark and Admiral Turner admit that they did not supply vital information to Kimmel because they both thought he was receiving it from other sources. The Naval Court concluded it was a matter of conjecture what further action 'Kimmel would have taken had he been furnished with the information available in the Navy Department'.

This writer does not recall seeing any mention of this review – available to us for some 35 years – in any book he has examined on the subject of Pearl Harbor. It is of interest that such men as Hanson Baldwin – for many years military analyst of the New York Times – has praised Puleston highly for his analytical writing in the field of military affairs.

Would The Japanese Have

Attacked Pearl Harbor Had FDR Followed The Sage Advice Given To Him By Admiral James O. Richardson And Returned The United States Fleet To Their West Coast Bases?

We learn from Vice Admiral Shigeru Fukudome, Chief of Plans and Operations of the Japanese Naval General Staff in 1941 who, in response to the specific question: Would Japan have attacked Pearl Harbor if the Pacific Fleet had been based on the West Coast of the United States?, responded:

Of course not. No attack on Pearl Harbor would have been contemplated or carried out. Without the fleet, Pearl Harbor was not a logical military target. We would never have considered attacking bases on the West Coast. Hawaii was far enough for Japan; the West Coast was out of our reach.

It would have been technically impossible to attack any American mainland base. If the fleet had remained on the West Coast Japan would have reverted to its traditional strategy of fighting the United States in waters fairly close to Japan's defense line.

Thus, the firing of James O. Richardson - Kimmel's predecessor - personally groomed by FDR to command the United States Fleet - who was fired by FDR for speaking his mind against the wisdom of basing the Fleet at Pearl Harbor - remains a very doubtful strategic decision. However, Richardson's firing may have served FDR from a longer range point of view. Certainly, there could have been no remaining doubts in the minds of Henry Stimson, Frank Knox, George Marshall, Harold Stark and "Ike" Eisenhower (in the European Theater) that regardless of doubt concerning any order from FDR, he would brook no

murmur of dissent however unwise the contemplated plan of operations.

# "The Powers That Be Resort To A Kangaroo Court"

Defined as: "a mock court in which the principles of law and justice are disregarded or perverted," Webster's Seventh New Collegiate Dictionary, G&C Merriam Company, Springfield, Massachusetts, 1971.

The principal source for much of what follows in this section is a small book containing 168 pages of text: The Shadow of Pearl Harbor; Political Controversy Over The Surprise Attack, 1941-1946; Martin Melosi, Texas A&M University Press, College Station, 1977.

A review appearing in *Choice*, March 1978, Volume 15, Number 1, reads, in part, as follows:

Historians have waited for years for a thorough and balanced account of the varied Pearl Harbor investigations. Now, with Melosi's book, we have a model monograph on this topic. This work based on a doctoral dissertation, is thorough, judicious and clearly written. The Knox Inquiry, Roberts committee, Army and Navy reports, Clausen and Hewitt investigations, Joint Congressional Committee hearings - each is given its due. . . . Admiral Husband E. Kimmel and General Walter Short he finds, were made "scapegoats" in a large-scale "cover-up". The administration helped create fears of Japanese "subversion", and such pro-administration journals as The New York Times abandoned professional responsibilities to rally behind their commander-in-

## Enola Gay Bombardier: No Apologies

Charlotte, NC (UPI) - The bombardier who dropped the atomic weapon that destroyed Hiroshima 45 years ago said he has no regrets or apologies, because his action ended WWII.

Thomas Ferebee, 71, told the *Charlotte Observer* in an interview published 5 Aug. that he did not know the blast he unleashed on 6 Aug. 1945 would wipe out the city and kill an estimated 140,000 people instantly.

Nor did hi know that it would be an irrevocable turning point in history.

That summer morning 45 years ago, Ferebee, then 26, a native of Mocksville, NC, knew he was getting ready to drop a special bomb, a secret weapon that could end the war.

"People have to go back and study the history of the war and the attitude of the people at that time," he said. "Everybody wanted the war to end. That's what I wanted the most. I wanted the bomb to work and end the war.

"So I felt good, since the first time we used it, it worked. I don't care how much confidence you have in science, until that bomb goes off, you're not certain," he said.

After the atomic bombing of Nagasaki, three days after Hiroshima, Japan surrendered, ending WWII on Aug. 15, 1945.

Ferebee, now a resident of Windemere, FL, joined the Army in 1940. After two years of flying school in the Army Air Corps, he was assigned to be a bombardier.

After flying missions to Europe and North Africa, he was assigned in 1944 to a B-29 bomber air crew with Col. Paul Tibbets, the pilot, Capt. Theodore "Dutch" Van Kirk, the navigator, and nine other men.

"There was no way that I was going to get into an airplane

without Ferebee and Van Kirk," Tibbets said. "They did exactly what they were supposed to do when they were supposed to do it. We were all young kids... but they were as professional as anybody you could possibly find."

On 6 Aug. 1945, the bomber Enola Gay lifted off while two technicians armed the huge, strange-looking bomb. About two hours from Hiroshima, Tibbets told the crew exactly what they were carrying, but Ferebee didn't hear. He was asleep.

It took 43 seconds for the bomb to fall and make its mark on history.

"At first, I saw this boiling on the ground and the stem (of the mushroom cloud) was going up and you could see buildings going up in the stem," Ferebee said.

"It was all colors. You can imagine, I think - brown, red, white - and it was spreading out in all directions. Then, finally, the stem formed completely and the top was there and it kind of broke off."

The inferno killed 80,000 to 200,000, according to assorted estimates, reducing victimes nearest the blast to blackened shadows on walls. Ferebee and Tibbets were blinded temporarily because they neglected to wear their dark glasses.

Van Kirk, 69, left the Army Air Force in 1946, returned to college for a master's degree in chemical engineering. From 1972 to 1978, he lived in Charlotte. Today he lives in San Francisco.

Tibbets stayed in the service, retiring in 1966 as a brigadier general. At 75, he lives in Columbus, OH.

Ferebee did not retire until 1970 after flying as an observer on bombing missions over Vietnam.

Ring is 10K or 14K Gold with blue zircon setting in a fireburst pattern. (Blue stone is the December birthstone and commemorates the attack on Pearl Harbor. Fireburst represents bomb bursts.) Surrounding the stone are the words "Pearl Harbor Survivors Association." On one shank is the PHSA seal and founding date "1958". On the other shank is a map of Oahu with "December 7, 1941" and "Remember Pearl Harbor". All raised surfaces are bright gold with background surfaces antique gold.

impeccable documentation. Virtually every major statement is supported by a citation.

In a review essay of 1983 Melosi writes with respect to revisionism:

I accept the revisionist claim that the Roosevelt Administration initiated a cover-up of Pearl Harbor. However, I reject the idea that FDR and his chief advisors had encouraged the attack and therefore were trying to conceal their guilt. I argue instead that they wished to protect Roosevelt's foreign policy by quashing a political controversy over the question of responsibility.

In this writer's correspondence with Melosi, this writer states:

"I have no difficulty whatsoever with the foregoing statement, at least not for my immediate purpose, which is to have Kimmel and Short restored to their war time ranks under a statute enacted during the Truman Administration. In your book: The Shadow . . . , you make it quite clear that FDR personally participated both in the genesis and outcome of the Roberts Commission, as well as in the efforts thereafter to preclude courts-martial for the Pearl Harbor Commanders. Thus FDR deprived two honorable men of that basic phase of due process which we accord the lowliest and meanest criminal in our midst. This point has never been clearly brought home to the intelligent sector of public opinion which can understand its significance."

Pursuing the findings of Melosi, we learn that on 8 December - the day after the Pearl Harbor attack - Tom Connally, the Senate Democrat from Texas and Powerful Chairman of the Foreign Relations Committee ". . . supposedly gave Secretary Knox 'uncharted hell' for Pearl Harbor." That very day Knox informed FDR of his decision to depart the next morning for a personal investigation of the damage done at Pearl Harbor. This was agreeable to FDR and Knox was requested to

report to the President immediately upon his return. However, instead of reporting first to FDR, Knox paid a visit to Stimson. He informed Stimson of the loss of personnel and the damage to ships.

"At this meeting they began to formulate a hard line for dealing with responsibility at the lower echelons of command, which would characterize the Roosevelt Administration's policy throughout the war."

In the 142 pages that follow, Melosi shows clearly the personal efforts of Franklin Delano Roosevelt - notwithstanding his pre-occupation with serving as Commander-In-Chief of World War II - to allocate his precious time to avoid being scorched by the heat generated by the "Kangaroo Court" known as the Roberts Commission, even including efforts to avoid granting Kimmel and Short a court-martial. The little book concludes as follows:

The preoccupation of Americans with a lapse in their Pacific defenses, as grave as it was, demonstrated the first real signs of uncertainty about US invicibility and invulnerability. Yet admission of any sort of national weakness was set aside in the pursuit of a rather elaborate search for scapegoats. In the cry "REMEMBER PEARL HARBOR!" is a hint of something beyond revenge against Japan - there is a hint about the state of political life in the United States during the war and after.

At this point it may be helpful to reinforce the youthful graduate student's doctoral dissertation with the commentary of the seasoned naval combat Veteran whom Roosevelt had fired just before nominating Kimmel – James O. Richardson. The latter had this to say about the Roberts Commission.

"I have been told, and I believe, that Justice Frankfurter suggested to the President the creation, under a carefully drawn precept, of a mixed commission composed of officers of the Armed Forces with a

civilian Counsel, and headed by a member of the Supreme Court, to investigate the attack on Pearl Harbor. His objective was to have a commission which would not be limited by the rules of evidence governing either a civilian court or a military court of inquiry. I was also told that the Chief Justice (Harlan F. Stone) was requested to serve, but refused the assignment.

"In the impression that the Roberts Commission created on the minds of the American people, and in the way it was drawn up for that specific purpose, I believe that the Report of the Roberts Commission was the most unfair, unjust, and deceptively dishonest document ever printed by the Government Printing Office.

"I cannot conceive of any honorable man being able to recall his service as a member of that commission without great regret and the deepest feeling of shame. The military members of the Roberts Commission . . . were later rewarded for their services by favorable assignments and promotion, or employment after retirement, but I cannot believe that such rewards were adequate compensation for their supine service to the President. Its procedures should have outraged every American.

"Its findings had been decided on before it ever met, for the decision to relieve Kimmel and Short was made prior to the initial meeting of the Roberts Commission. Had the Roberts Commission been intended to do a factual job, such a removal would have been untimely, to say the least, since it presented to the Commission a finding of culpability.

"A more disgraceful spectacle has never been presented to this country during my life time than the failure of the civilian officials of the Government to show any willingness to take their share of responsibility for the Japanese success at Pearl Harbor.

"Before the Roberts Commission, the leaders of the Armed Forces of the United States, who were the victims of the initial attack in this aggressive war by the Japanese, were not given a trial, were not permitted to introduce evidence in their behalf, and were not allowed counsel. Yet, these leaders were found guilty of dereliction of duty by the Commission, and were crucified in the public press and at the bar of public opinion in the United States."

Although there is much more that Admiral James O. Richardson has to say, it is clear that he has made his point. This writer would like to suggest - fortunately for the judicial process in this Country - an appeal was not taken by the heirs of the Kimmel and Short families - if such is possible - to the Federal Courts. Can anyone imagine what might have transpired had this case come before the United States Supreme Court - two of whose leading Justices had allowed themselves to become involved beforehand - in such a travesty of the judicial process?
