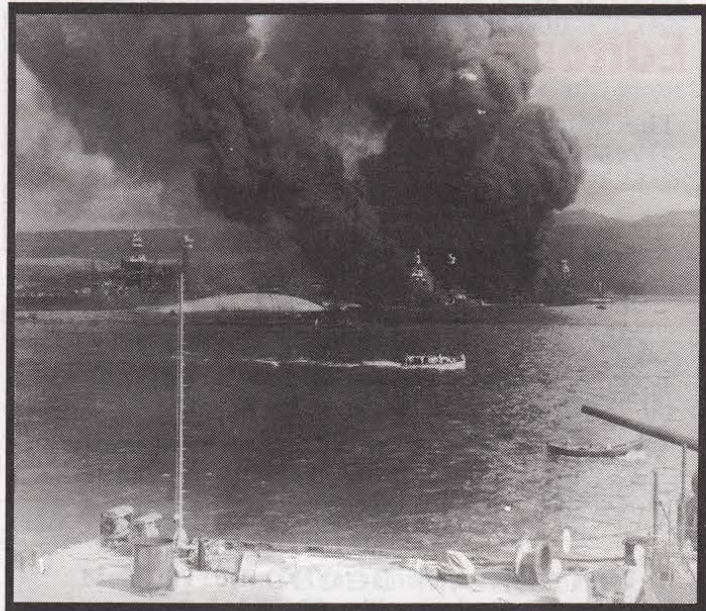

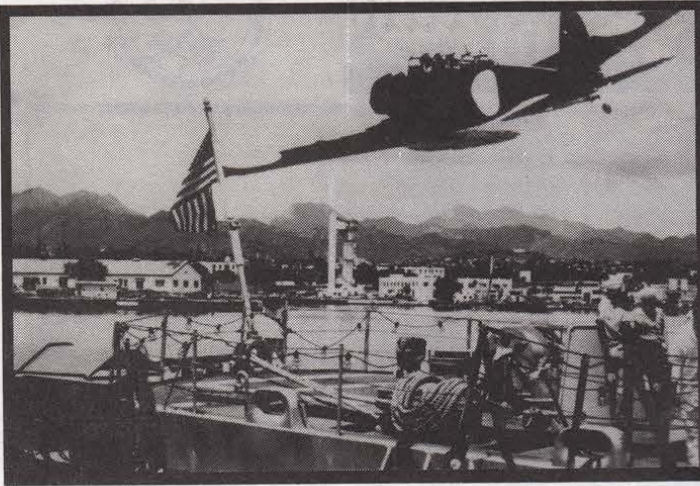

## WWII 'Personal Accounts' Exhibition

As America prepares to commemorate the 50th Anniversary of WWII, a major exhibition, titled "World War II: Personal Accounts - Pearl Harbor to V-J Day," is scheduled to open in San Antonio, TX, on 7 December at the San Antonio Museum of Art.

The exhibition is the centerpiece of the National Archives commemoration of the 50th Anniversary of U.S. participation in WWII and will travel around the U.S. for the duration of the 50th Anniversary commemoration period. After leaving San Antonio in late March 1992, the exhibition will be shown in a number of presidential libraries and other locations, ending in Washington, DC at the National Archives.

Though more than 200 first-hand accounts from the front lines, diaries, letters, telegrams, personal memorabilia and photographs, the exhibition will bring to life the human experiences of the men and women who defended democracy in

the face of its greatest challenge.

Using personal narrative, the exhibition will focus on 15 major episodes of the war: Pearl Harbor; Bataan, Corregidor; Doolittle Raid; Coral Sea, Midway; No. Africa; Guadalcanal; Stalingrad; China, Burma, India; Sicily, Italy, Anzio; Normandy and France; The Bulge, Germany, The Elbe; Island Hopping; V-E Day; The Atomic Bomb; V-J Day.

Among the historically significant items planned for the exhibit are:

- A rare film depicting the actual Japanese attack on Pearl Harbor;
- Franklin D. Roosevelt's draft of his "Day of Infamy" speech asking Congress for a declaration of war;
- Letters and diaries from soldiers, sailors and Marines recounting major episodes of the war.

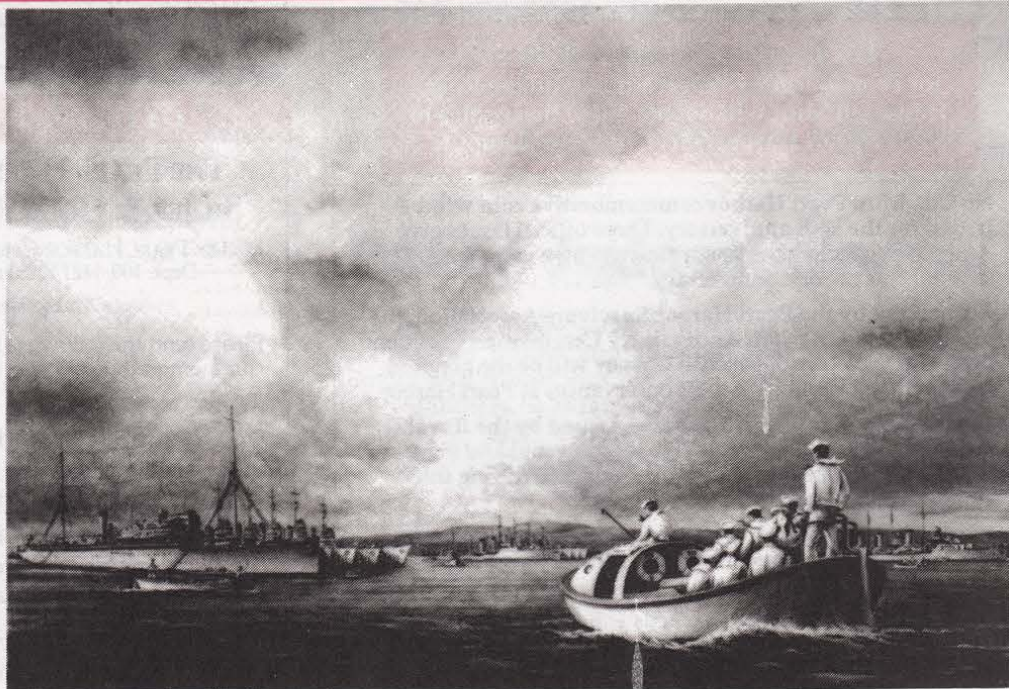

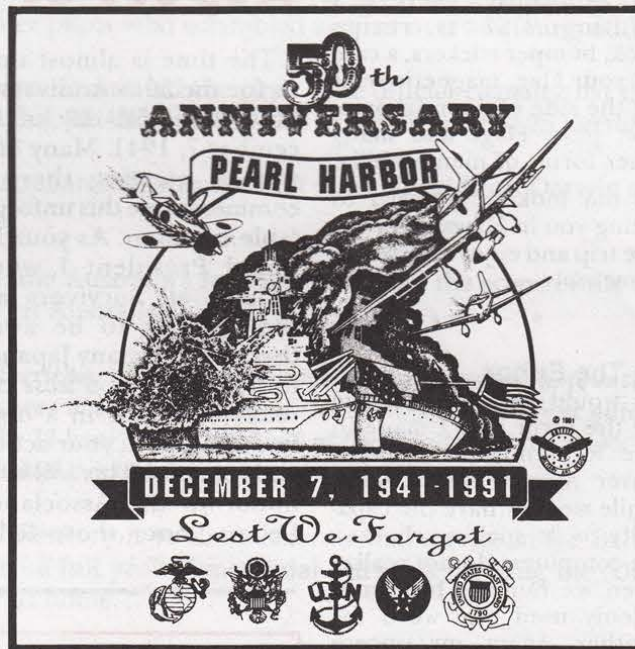

"What the Battle for Britain required, so the Battle for Australia  
demands." PRIME MINISTER JOHN CURTIN, 1942, ON THE  
EVE OF THE FIRST OF SIXTY-FOUR AIR RAIDS ON DARWIN.

75 days after the assault on Pearl Harbor four carriers from Japan's strike force were in position off Northern Australia.

They launched 188 aircraft on the morning of February 19th 1942 against Darwin, Capital of the Northern Territory. A second wave of 54 bombers followed two hours later.

The first casualties included 81 men on the US destroyer Peary sunk in Darwin Harbour with guns blazing, and American fighter pilots who scrambled against overwhelming odds.

Japan's Pearl Harbor veterans devastated the city. The official casualty list that day was 243 killed, more than 300 wounded, 21 Allied ships sunk or damaged, and 25 aircraft destroyed.

This, the first attack on Australian soil, was the first of 64 air raids on Darwin over the next 21 months.

The Northern Territory became Australia's frontline at home - the scene of the first conflict, and the only sustained conflict, on Australian soil.

*U.S. forces poured into the Territory. Transport groups trucked massive amounts of materiel to Australia's Top End, U.S. forces developed many of the 50 airfields brought quickly into operation, bomber crews flew 14 hour round trips out of the Territory until war's end and Darwin Harbor was a key port for naval vessels.*

Now, in 1992 the Northern Territory is to commemorate that service in the Battle of Australia War Service Memorial Year - a full year of memorial activities marking the 50th Anniversary of the start of Australia's war at home.

60,000 Americans served in the Territory theatre, side-by-side with their Australian, British, Dutch and Canadian allies.

A warm invitation has been extended to these men and their families to return in 1992.

Northern Territory Chief Minister, the Hon. Marshall Perron, M.L.A.: "Our memorial year will provide lasting recognition for those who served and help younger generations understand the partnership forged in conflict so long ago between our two countries. In 1992 we look forward to many United States veterans sharing what is destined to become one of the most significant war service memorials ever held in the region. To those who are part of our history, join us in 1992 and again let us fly our flags together."

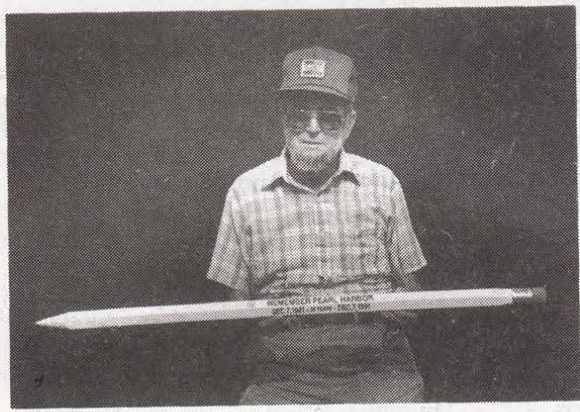

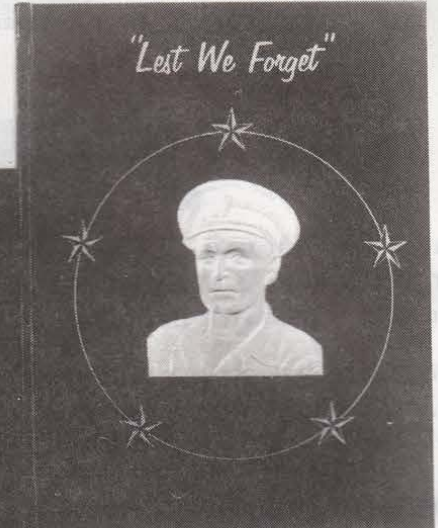

# Pearl Survivors plans to unfurl a gigantic flag

The Pearl Harbor Survivors Association's big plans for December include the unfurling of a really big Flag to be known as the Pearl Harbor Flag.

Survivors Association President Gerald Glaubitz said his group is working with people on the Mainland to bring an 85-foot-by-40-foot Flag to Honolulu for the 50th Anniversary commemoration.

The group hopes to hang the huge 48-star Flag on Aloha Stadium in such a way that all of the Pearl Harbor Survivors who gather in December can have their picture taken at one time with the Flag behind them.

The Association plans to have between 4,000 and 5,000 members and guests on hand for an early morning commemoration at Punchbowl on December 7 and a sunset ceremony that evening at the USS Arizona Memorial Visitors' Center.

PHSA has invited Secretary of Defense Dick Cheney to be guest speaker at Punchbowl. The group is hoping President Bush will take part in the sunset ritual.

The Association plans to lead a December 6 parade down Kalakaua Avenue with more

than 2,000 veterans from about 20 veterans groups.

Chrysler Corp. has offered to send 76 World War II-era vehicles to Honolulu for the parade.

On December 8, PHSA members will gather at the Sheraton-Waikiki Hotel for a banquet. The hotel's largest ballroom already is booked beyond its

capacity and plans are being made to accommodate more people with a TV hook-up.

The National Park Service is planning its own Survivors' Day commemoration on December 5. The governors of nine "Battleship States" have been invited to give talks along with Survivors from each of the ships - Arizona, California, Mary-

land, Nevada, Oklahoma, Pennsylvania, Tennessee, Utah and West Virginia.

Also invited to take part are Franklin Van Valkenburgh, the 74-year-old son of the captain who commanded the USS Arizona; and Medal of Honor winner Captain Donald K. Ross, who was aboard the USS Nevada.

*Let us all get together with this attempt to have every radio station in the United States play the recording of "Remember Pearl Harbor" at 7:55 a.m. on December 7, 1991. Make copies of the following letter and send it to radio stations in your area.*

Gentlemen:

December 7, 1991, will mark the 50th Anniversary of the surprise attack by the Japanese Military on U.S. Armed Forces on the Island of Oahu, Territory of Hawaii. At 7:55 a.m. on December 7, 1941, the first wave of Japanese aircraft attacked the US Navy Ships in Pearl Harbor and Army, Army Air Corps, and Marine Bases throughout the Island. In that attack the United States lost 21 ships sunk or damaged, 328 aircraft lost or damaged, and 2,403 Military Personnel killed and 1,178 wounded. Of those killed, 1177 Navy Personnel are still entombed in the USS Arizona. This undeclared act of war by the Japanese, forced the United States into World War Two.

Shortly after the attack, Big Band Leader Sammy Kaye made famous a song that became the battle-cry of our forces in the Pacific. That song "*Remember Pearl Harbor*" did for our fighting men in World War Two what "*Over There*" did for our troops in World War One.

In is our sincere request that your Radio Station along with other Radio Stations across the nation, play "**REMEMBER PEARL HARBOR**" on December 7, 1991 at 7:55 a.m. Honolulu, Hawaii time.

There are over 12,000 known Survivors in the Pearl Harbor Survivors Association and many of us will be attending the 50th Anniversary Memorial Services and Reunion in Honolulu on that date. Each and every Survivor and the relatives of those killed on December 7, 1941 will feel honored if you will grant this request. The Motto of our Association is *Remember Pearl Harbor - Keep America Alert.*

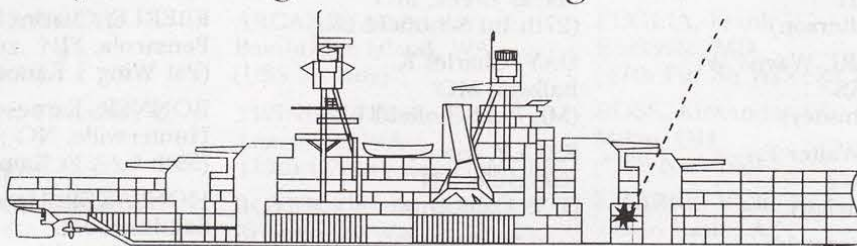

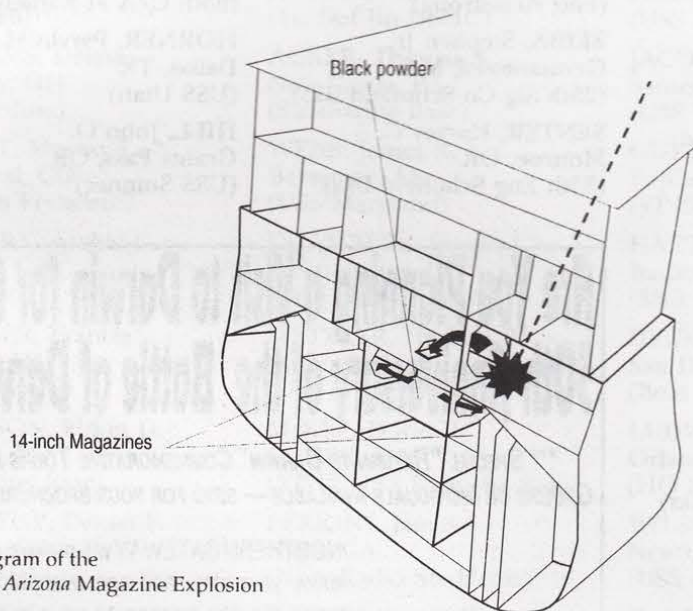

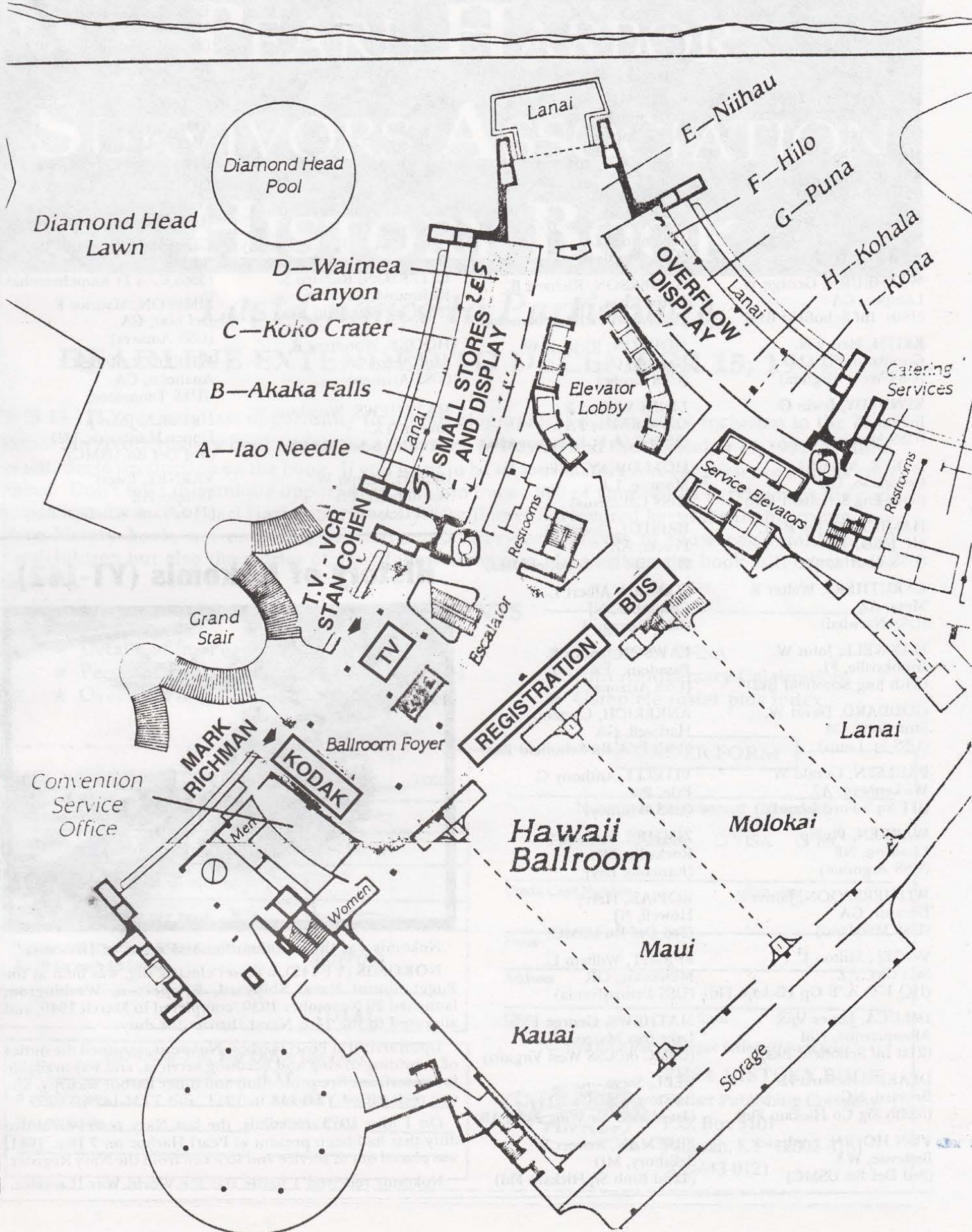

## History of Nokomis (YT-142)



Nokomis was the grandmother and nurse of Hiawatha.

**NOKOMIS** (YT-142), a diesel electric tug, was built at the Puget Sound Naval Shipyard, Bremerton, Washington; launched 29 November 1939, completed in March 1940, and allocated to the 14th Naval District for duty.

Upon arrival at Pearl Harbor, **Nokomis**, assumed the duties of providing towing and berthing services, and was available for waterfront fire protection and inner harbor security. She was reclassified YTB-142 in 1944, and YTM-142 in 1965.

On 1 May 1973, Nokomis, the last Navy vessel on active duty that had been present at Pearl Harbor on 7 Dec. 1941, was placed out of service and stricken from the Navy Register.

Nokomis received 1 battle star for World War II service.

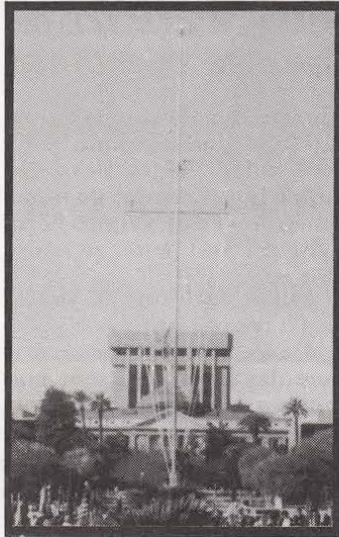

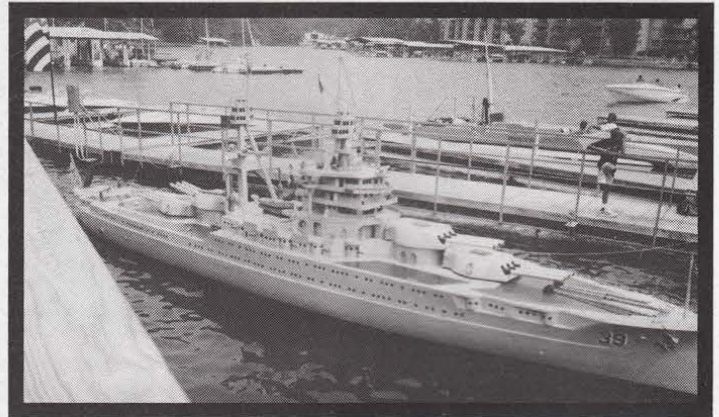
including a busload of USS Arizona PHSA members who came up from Tucson where they were holding a reunion.

## Praise the Lord, pass the hat

### Pearl Harbor vets, now retired, find it tough to pay for visit

The fresh-faced 20-year-old Navy men and Marines who survived the Pearl Harbor attack 50 years ago are wrinkled now.

Most are retired and living off pensions or benefits of one sort or another.

As young men, they made a heroic effort at a critical moment in the nation's history, and now 50 years later, the events they are planning to remember those days are being seen as a last hurrah of sorts for their generation.

Some came here for Pearl Harbor Anniversary commemorations in the past. Others will be returning to the Islands for the first time since the war ended.

For many, the cost of flying to the 50th State for the 50th Anniversary and staying in a Waikiki hotel at 1991 rates will be a financial hardship, according to Gerald Glaubitz, National President of the Pearl Harbor Survivors Association.

"We've got a lot of senior citizens on Social Security and many are stretching their dollar thin because they decided they wanted to

come out," said Glaubitz, who is in Honolulu for planning meetings this week.

Some of the Pearl Harbor Veterans are comparing the room rates they will have to pay and the reduced rates the hotels laid on a few months ago to welcome home the men and women of Operation Desert Storm.

"There's no ill feeling or anything, but nobody has given us half-price yet like they gave the veterans of Desert Storm," said Glaubitz, who is Mayor of Morningside, MD, a small town near Andrews Air Force Base.

Bill Eckel, Treasurer of the Survivors Association, said the tab for the Association's 50th Anniversary events will come to more than \$175,000.

For example, it will cost \$25,000 just to charter buses to take the Pearl Harbor veterans to the National Memorial Cemetery of the Pacific at Punchbowl on the morning of December 7.

"We're planning to charge \$10 a head, but we have people who can't afford that.

In addition, we're putting on a banquet and dance," said Glaubitz.

"If you can find an angel for us, who wants to give us a little money toward all this, that would be fine," Glaubitz told a reporter. "If you can find us \$175,000, we can give our people a free ride."

Some Association members have complained that the USS Arizona Memorial needs a coat of paint.

Glaubitz said he hadn't been out to the memorial yet this year. But, he said, if paint is what's needed, it would be nice if a civic-minded corporation would step forward to help the government make the memorial ship-shape in time for the Anniversary.

"If they need help getting a paint brush over there, I've got no problem with (a private sponsor)."

Glaubitz was a fire controller aboard the heavy cruiser USS San Francisco in December 1941. He retired in 1974 from the Naval Research Laboratory where he worked in radar and missile guidance.

He was dead-set against the

idea of having any official Japanese government representation at the December 7 ceremonies because, he explained, members felt Tokyo had never apologized for the attack.

"We have nothing against the Japanese today," he said. "The only thing we're against is the Japanese government that decided to pull a sneak attack and didn't say boo."

Glaubitz contrasts the Japanese government's silence with the American government's decision to make redress payments to U.S. citizens and aliens of Japanese descent who were interned.

"This country turned around and said that was wrong and offered payments of \$20,000," he said. "Now, if the Japanese government would offer to do that with us, we'd be glad to sit down and talk with them."

In the meantime, Glaubitz said the American public would be well-served by remembering the Association's motto: "**Remember Pearl Harbor, Keep America Alert!**"

# Pikes Peak Chapter

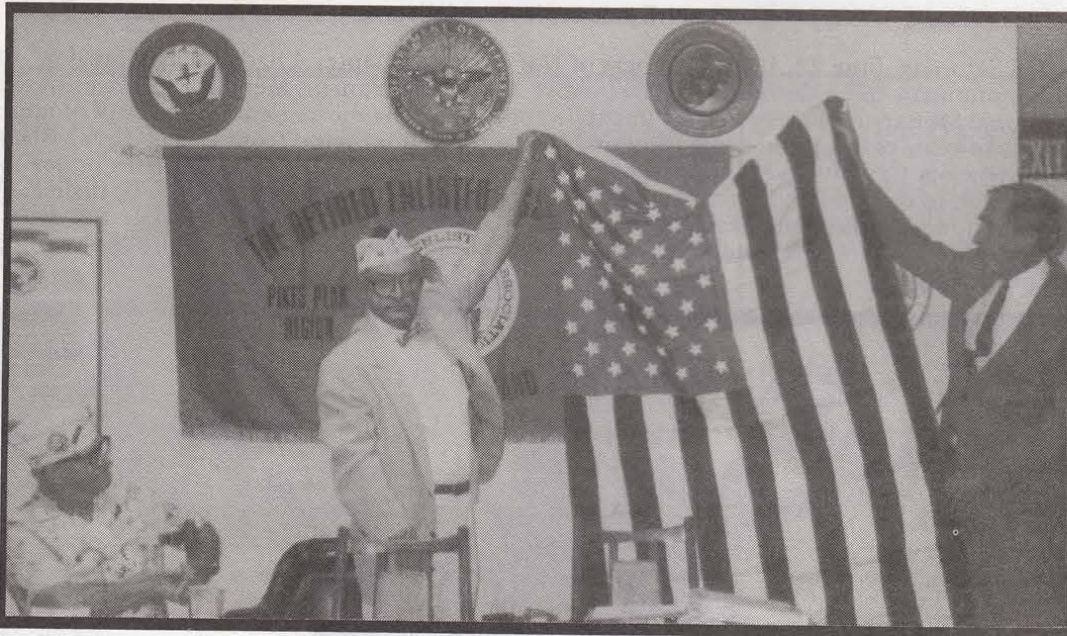

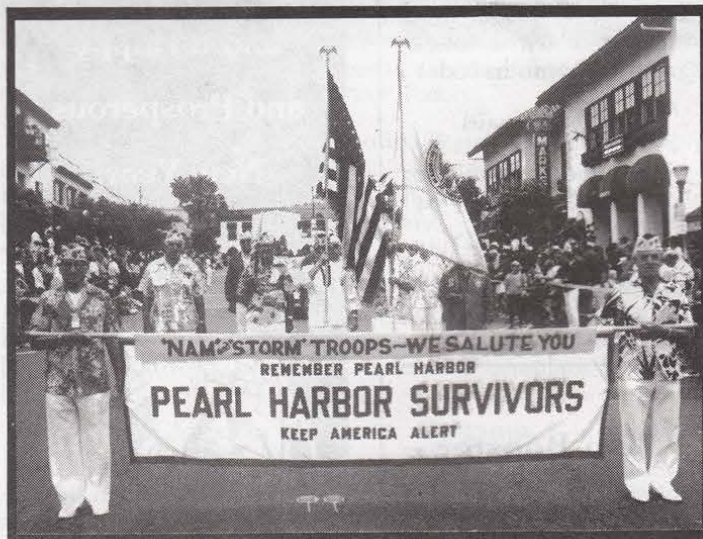

## History of Osceola (YT-129)

Osceola, the son of an Englishman and a Greek mother, was born in Georgia about 1800. A noted Seminole Chief and leader during the second Seminole War, Osceola was seized when he appeared for a conference in October 1837, and died in prison at Fort Moultrie, S.C. on 30 January 1838.

**OSCEOLA (YT-129)** was launched at the Navy Yard, Charleston, S.C. 3 March 1938, and placed in service 1 June 1938. She was named **Osceola** on 17 September 1938, and reported to the 14th Naval District for duty as a yard tug at Pearl Harbor, T.H.

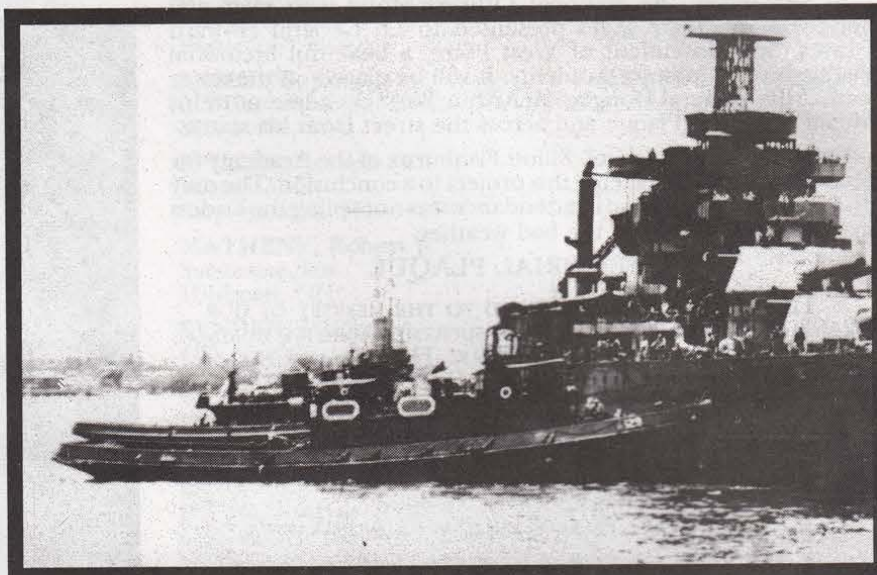
7 December 1941, Osceola assisted in firefighting, rescue and salvage work. Most of the period, from the evening of 7 December until 2055 Wednesday 10 December 1941, she was alongside CALIFORNIA (BB-44) pumping, pushing, furnishing food and other services necessary to save CALIFORNIA.

Osceola remained at Pearl Harbor engaged in the many duties of Yard Tugs throughout and after World War II.

Her designation was changed to YTB-129 on 12 April 1944 and to YTM-129 on 1 February 1962.

Osceola was placed out of service, stricken, and sold 15 February 1973.

Osceola received 1 battle star for World War II.



## Remembering Pearl

From the Newark, New Jersey *Star Ledger*

A faithful reader, Lee Goldfarb of East Hanover is not very happy with our report that Howard Stringer of CBS has no objection to the Japanese joining forces with his network to offer their anniversary views of the attack on Pearl Harbor 50 years ago.

As national vice president of the Pearl Harbor Survivors Association, Goldfarb has asked for (and we think he deserves) equal time. He writes:

"I must take issue with CBS...in covering the events of that special day this Dec. 7. In addition, the flippancy of Howard Stringer, the president of the CBS Broadcast Group (who jokingly suggested the network might round up any surviving Kamikaze pilots and restage the attack), was certainly not called for and, in my opinion, not in the best of taste."

"I certainly believe in freedom of the press (TV and Radio included), but sometimes good judgment and good taste should prevail."

"This is **Our 50th Anniversary** and we simply wish to observe it with all possible dignity and decorum. Neither are we ready at this particular time to kiss and make up."

"Dec. 7, 1941 was not an act of war—it was a sneak attack which cost the lives of 2,400 of our shipmates and comrades. Those soldiers, airmen, sailors and Marines did not die in battle, but were murdered just as if they were victims in a holdup."

"If indeed the Japanese wish to apologize to them, it should originate from either the Emperor or Prime Ministers of Japan. If they wish to apologize, let them pay the next of kin of those killed \$20,000 as an indemnity."

"Am I angry at the grandchildren of those who planned the attack? No! Am I angry at the citizens of Japan? No! But for most of us, this will be our final farewell to our shipmates and comrades still entombed in the USS Arizona or buried in Punch Bowl Cemetery. Let us mourn our loss quietly, without the hoopla."

"OK, Mr. Stringer? OK, CBS?"

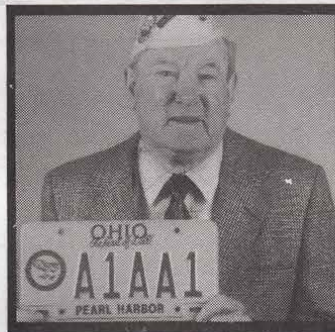

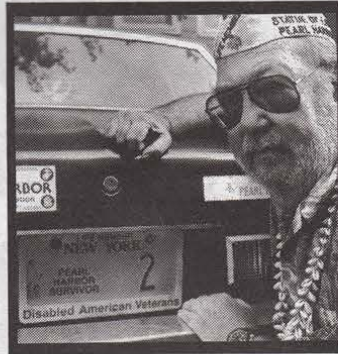
