

# Pearl Harbor Survivors Day in Westfield, PA

Thirty-seven Pearl Harbor survivors gathered at the Westfield Elementary School on October 25, 1991 with approximately 300 faculty and students and others to commemorate the 50th anniversary of the attack on Pearl Harbor, December 7, 1941. The mayor of Westfield and the Commissioners of Tioga county issued proclamations declaring October 25th to be "Pearl Harbor Survivors Day" throughout the area. There was a

widespread display of

flags, signs and other pa-

triotic symbols.

The Tioga County Amateur Radio Club set up equipment in one classroom and in a three hour period communicated with more than 80 amateur radio operators throughout country on PHSARN frequencies. Several net members at the school manned the microphones for part of this time. Certificates verifying the contacts were sent to all those contacted, some of whom were Pearl Harbor survivors.

Two important items were dedicated. The first was a book compiled by the students based on the volume of letters and memorabilia received from survivors. (see August 1991 Gram, page 7). Titled "We Will Remember Pearl Harbor" it has been widely disother tributed to educational activities and survivors as well as the President of the United States, George Bush. The second item is an American flag which had been flown over the USS Arizona in Pearl Harbor. It was donated to the school by Eugene Price W6RBD. It is displayed in a place of honor in the all purpose room of the school.

## Tennessee "Volunteers" Commit a Plaque and a Flag to Posterity

Twenty-three Tennessee Pearl Harbor Survivors and two Widows were awarded the 50th Anniversary Congressional Commemorative Medal in ceremonies on December 7, 1991. Fifty years and Father Time may have dimmed our physical vision, we said. but not the memories of those of us who were "there" on December 7, 1941, nor our commitment to "Keep America Alert."

For weeks we had shared our stories with the Press, TV and Radio. Many of these had been secretly stored in the distant reaches of the mind, but were painfully recalled once more in an effort and a renewed commitment to somehow alert a new generation of the dangers of complacency.

To keep this story alive, our Tennessee chapters secured a plaque containing the names of every known Tennessee Survivor. The Tullahoma High School Band took the plaque to Pearl Harbor for certification during December 7 ceremonies there and it will be displayed in the War Memorial Building in Nashville. Its purpose is not only to permanently memorialize those who gave their all at Pearl Harbor, but to keep in the forefront of future generations the lessons learned on December 7, 1941. Senator Albert Gore, Jr. presented Chapter 4 with a flag which had flown over the Tomb of the Unknown Soldier in Washington, D.C. The symbols of this flag and this plaque with our names inscribed must be our legacy and our promise that 2,403 did not die in vain.







### **Hickam Field**

Russell L. Waldron, 31st Bomb Squadron, delivered the Invocation at the Flag Pole Ceremony at Hickam Air Force Base during the 50th Anniversary Memorial Services. Included in the ceremony was the dedication of a Memorial Tablet which listed the names of the 190 persons who were killed during the Japanese attack. The following paragraphs were the closing remarks of his Invocation.

know, it was fifty years ago today that hundreds of our Sailors, Airmen, Marines and Soldiers made the Supreme Sacrifice here at Pearl Harbor. They died in the Defense of the United States of America. They were MURDERED. They were murdered because of orders from the Japanese Government at that time. The aerial attack was illegal. It was unlawful. The attack was made deliberately, willfully, and with premeditated malice. It was a sneaky, surprise attack. It was a dastardly, terrible, and tragic attack.

Since then, NO JAPA-NESE GOVERNMENT HAS EVER APOLOGIZED FOR THIS ATTACK. The very great majority of Pearl Harbor Survivors have strong convictions that the current Japanese Government should apologize for this attack. It is true that the Foreign Minister of Japan has recently expressed his deep remorse for the unbearable suffering and sorrow caused by the attack. However, the present Japanese Government has not made a formal declaration of apology.

Almighty God, we know that You want us to forgive

and forget. We also know that it is your will that forgiveness comes after repentance. We know that a
person or nation that injures another person or
nation must first express
his sorrow and then apologize for the injury. An apology must be made before

Almighty God, help us to forgive and forget. Help us to participate in the healing process of our two Nations."



# **Texas Chapter 4 Monument**

Dedication Speech at Punchbowl National Memorial Cemetery of the Pacific, Honolulu, Hawaii given December 7, 1991 by Houston James



Today we have journeyed to this sacred memorial cemetery to pay our respects and to honor our fallen comrades, those that fell during the attack on this day fifty years past. It is traditional for Pearl Harbor Survivors to do so wherever we are on December 7. Part of our heritage also, embodied in our National Motto, is the word REMEMBER.

We the survivors remember. We remember the peacefulness of an early Sunday morning. We remember the earth shattering thunder that robbed us of our calm serenity. Each of you that bore witness to the events of that December day will always remember. You Remember - It was not the crash of thunder, but the arms of war that stole away our calmness in paradise. Each of you has your individual remembrances indelibly etched in your mind. Along with us, millions of others of that era join us in remembering. Especially those who were asked to take up the sword, to rally with us to defend our freedom.

To all of us, this day, 7 December, will always be remembered as Pearl Harbor - "A Date that will live in Infamy." Please do not ask us to forget, to do so would be a mockery of the 3,500plus who were casualties as a result of that attack. Remember, all those who perished or sustained wounds were not just names on a roll call - to us, they Survivors, they were friends, buddies, shipmates, fellow warriors. Whatever title you choose is fine. It is an awesome tragedy that they were denied the title that we all share, the title "Survivor." So today it is our legacy as Survivors to gather together to renew our pledge, to remember.

On this day, the 50th Anniversary, we are privileged to dedicate a memorial in honor and memory of those events. This memorial is chiseled from granite and adorned with a tablet cast in bronze - materials chosen to withstand the elements for the ages. This is our token of remembrance. It will soon find its rightful place at the newly created Memorial

Walkway here at this beautiful National Memorial Cemetery of the Pacific (Punchbowl). We, the living, dedicate this memorial monument especially to those who fell on December 7, 1941. We also wish to remember today the thousands who wore the badge of Survivorship then, but have since departed to join the others in eternal rest. It is our prayerful wish that future generations strolling these hallowed grounds will reflect on this memorial and remember Pearl Harbor. We have proudly inscribed on this tablet our solemn oath:

"We the Survivors remember, you who gallantly fell we shall never forget."

If my wonderful partner, my gracious wife Marion will please honor us, I shall ask Mr. Bryon Thomas, 96 years young, and Mr. Marve Ziegler, California Chapter 31, to assist in placement of our Mailie Lei.











# PHSA Honor/Memorial Fund

By Nat'l Secretary Ken Creese

At its meeting on October 17, 1991, the PHSA Executive Board recognized a need for a means of accounting for gifts, donations and bequests which are offered by individuals and organizations (corporations, associations, etc.) in honor of and to memorialize the Pearl Harbor attack and the members of the Armed Forces who defended their country on December 7, 1941. Typical of such offerings are gifts dedicated to a particular person or donations in lieu of flowers on the death of a survivor. The Board desired that such receipts be formally acknowledged by the Treasurer in behalf of PHSA and segregated from income from dues and subscription fees to observe the restrictions placed upon such revenue.

The Board authorized the Treasurer to establish accounts for a PHSA Honor/ Memorial Fund to receive money and property given by donation or bequest to honor

members of the Pearl Harbor Survivors Association or other persons who participated in the defense of the United States at the attack on December 7, 1941. The Board decided that until the general membership had confirmed the desirability of establishing a PHSA Honor/Memorial Fund that expenditures should not be made from the fund except where the provision of a plaque at the U.S. Coast Guard Academy required support. The Board stated an intent to expend all receipts into the fund within the anticipated life of PHSA and not to create an endowment or trusteeship for funds received into the Honor/ Memorial Fund. Expenditures authorized by the Board will recognize terms or restrictions placed on donations by the donor not in conflict with National Constitution and By-Laws but not for the benefit of specific individual(s).

On December 4, 1991, the Executive Board confirmed its previous action and directed that its decisions be communicated to the general membership for endorsement at the 1992 Convention.

## Pearl Harbor Survivors Association, Inc. **Financial Statements**

INDEPENDENT AUDITOR'S REPORT - NOVEMBER 29, 1991

To the Board of Directors - The Pearl Harbor Survivors Association, Inc.

I have audited the accompanying statement of assets, liabilities, and fund balance-cash basis of The Pearl Harbor Survivors Association, Inc. as of September 30, 1991, and the related statement of revenue, expenses, and changes in fund balance-cash basis for the year then ended. These financial statements are the responsibility of the Association's management. My responsibility is to express an opinion on these financial statements based on my

Except as set forth in the following paragraphs, I conducted my audit in accordance with generally accepted auditing standards. Those standards require that I plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. I believe that my audit provides a reasonable basis for my opinion.

I was not present to observe the taking of the physical inventory at September 30, 1991 (stated at \$7,370), and the Association's records do not permit adequate retroactive tests of those inventory quantities.

As described in Note 1, the Association's policy is to maintain its records on the basis of cash receipts and disbursements; consequently, certain revenue and related assets are recorded when received rather than when earned, and certain expenses are recorded when paid rather when the obligation is incurred. This basis is a comprehensive basis of accounting other than generally accepted accounting principles.

In my opinion, except for the effect of such adjustments, if any, as might have been determined to be necessary had I observed the taking of the physical inventory, the financial statements referred to in the first paragraph present fairly, in all material respects, the assets, liabilities, and fund balance of The Pearl Harbor Survivors Association, Inc. as of September 30, 1991, and its revenue, expenses, and changes in fund balance for the year then ended, on the basis of accounting described in Note 1.

My audit was made for the purpose of forming an opinion on the basic financial statements taken as a whole. Schedules A through H are presented for the purpose of additional analysis and are not a required part of the basic financial statements. Such information has not been subjected to the auditing procedures applied in the audit of the basic financial statements, and accordingly, I express no opinion on them.

#### NOTES TO FINANCIAL STATEMENTS YEAR ENDED SEPTEMBER 30, 1991

#### NOTE NO.

#### 1. SIGNIFICANT ACCOUNTING POLICIES

The Association is a nonprofit tax-exempt entity as defined under Section 501 (c)(19) of the Internal Revenue Code. The Association is federally chartered and is operated exclusively for purposes beneficial to the interest of the nation and its uniformed services personnel, their dependents and survivors.

The accompanying financial statements have been prepared principally on a modified cash basis, with the following exceptions: (a) Deferred Life Membership Dues are recorded as they accrue over a ten year period; (b) Prepaid Convention Expenses are deferred until the year of the convention and the fees received for the convention are shown as convention deposits until the year of the convention; (c) Interest income on zero coupon bonds is recorded as earned (See Note 3); and (d) Prepaid insurance is recorded and expensed over the life of the policy.

Inventory is priced at lower of cost or market value, on the first-infirst-out method.

#### 2. DEFERRED LIFE MEMBERSHIP DUES

Current Deferred and Long-Term Deferred Life Membership Dues are carried as liabilities. Life Membership Dues are presently amortized over 10 years where as Annual Membership Dues are recognized in the year received.

#### 3. ADJUSTMENT TO FUND BALANCE

Under current accounting guidelines nonprofit organizations are now required to depreciate long-lived tangible assets such as furniture and equipment. Accordingly, the Association has recorded depreciation for the current year of \$295 and \$6,083 for all prior years. The \$6,083 has been shown on the attached financial statements as a reduction to Fund Balance.

#### 4. RELATED PARTY TRANSACTIONS

The Association pays rent to certain of its officers for the use of space in performing their duties.


