BILL INTRODUCED FOR USS UTAH

Senator Frank E. Moss (D., Utah) has introduced a bill in the 90th Congress directing the Secretary of the Navy to erect a flagpole over the hulk of the USS UTAH at Pearl Harbor, and that a flag be raised each day.

The Senator said "recognition should be given to these 54 officers and men who lost their lives on December 7, 1941, during the attack on the American fleet. The dead of the USS UTAH have been too long neglected." He introduced similar legislation in the 88th and 89th Congresses.

Recommend all Survivors write immediately to their Congressman to vote in favor of this bill.

I have examined the accompanying Statement of Financial Condition as of December 31, 1966 and the Statement of Cash Receipts and Disbursements of the Pearl Harbor Survivors Association, Inc., for the twelve months ending December 31, 1966. My examination was made in accordance with generally accepted auditing standards and accordingly included inspection or confirmation of assets owned as of December 31, 1966, and such other auditing procedures which I considered necessary in the circumstances. I previously examined and reported upon the financial statements of the Association for the previous year.

The account receivable from Fitzpatrick Travel Service represents a portion of the surplus funds of the Hawaiian Reunion which you voted to have remain with the Association as a partial reimbursement for its expenses concerning the reunion. The balance of the refund from Fitzpatrick Travel Service, which exceeds the \$7718.73 due the Association, will be prorated and refunded to the adults that participated in the Hawaiian Reunion who were booked with the Fitzpatrick Travel Service.

In my opinion, the aforesaid financial statements present fairly the financial position of the Pearl Harbor Survivors Association, Inc., at December 31, 1966 and the results of its operations for the year then ended, in conformity with generally accepted accounting principles applied on a basis consistent with the preceding year.

(e) ALL MEMBERS of the association encouraged to send in material for publication; I will edit it or reject it, as a spokesman of the association; if rejected it will be returned to you with note of explanation.

(f) To ENLARGE and IMPROVE on our GRAM, we need BOOSTERS AND ADVERTISERS, at \$10.00 minimum (per 5 lines), plus \$2.00 for each additional line, for the Full Year. It is believed this was the first program of this kind ever held in Minnesota in honor of those who did not survive. An impressive attendance was present.

A noon luncheon was held at the Leamington Hotel given by the Twin Cities Chamber of Commerce. Many dignitaries were present, including three Generals on active duty, one being Major General Walter A. Jensen, A Minnesota Survivor and Life Member of PHSA, Inc., a West Pointer and presently the XIV Area Commander.

The evening activities for the Survivors and their families were held at McGuires in Minneapolis. Everyone wore a colorful lei and the girls wore orchids in their hair. The food was served in Hawaiian fashion. Yes, even poi was served. The participation was terrific and a "ball" was had by all!



When the fireworks started, he returned to the base but found that his ship was already gone. He assisted taking survivors out of the water; later in the day, he was taken aboard the USS WARD and partolled the harbor area for several days. Following this, he returned to the USS Allen. Elmer returned to Honolulu last December with us and participated in the 25th Anniversary Reunion. Early in February, he suffered a heart attack and is not expected to return to work for several weeks.

Standing, left to right, Elmer Parsons (Schofield Barracks), Robert Gregg (USS Solace) both of Aurora, III., Frank Little (USS Oglala) of Elburn, III., and Alex Mihalka (USS Oklahoma) of Aurora. Sixth District Partolman Bernard Blell, Life Member of PHSA, was the only one of the five to fire back at the attacking planes. Bernard had just finished breakfast and was waiting for a liberty boat when the word was passed "It's the Japs, no fooling." He volunteered for a crew for a three-inch gun aft. There should have been a crew of nine men on the gun but they had only five — a cook, a yeoman, a boatswain's mate, a seaman, and Bernard, a fireman. They did not have a gunner's mate to help them but they shot down one of the Jap planes.

SGT Henry Hummert, of the Fourth District is the third St. Louis police officer who was aboard the USS Allen. He was ashore and on his way to church when the Japanese struck. Realizing what was taking place, Henry returned to the naval base but his ship had left. He aboarded the USS Ward for nine days and then was returned to the USS Allen.

SGT Walter Havey was attending the Machinist's Mate School at Pearl Harbor but was quartered on the USS Arizona. Walter is now a member of the Army Reserve and is presently Chief Warrant Officer in the 102nd Infantry Division.

Fourth District Parolman Frank Wolinski is the only Pearl Harbor Army veteran of the five St. Louis police officers.

Saddness marks this group of five—Patrolman BLELL was called in early March to serve on the Staff of the High Command. National Vice-President Jerry Gammon and twenty-two members of the Pearl Harbor Survivors Association attended the funeral services.
