#### OFFICIAL RULES OF MEMBERSHIP CONTEST

A new member is considered one who is NEW, not renewing, nor, one who is changing from an annual dues paying member to a lifetime member. If he is a survivor who has dropped out of the PHSA and wants to rejoin by paying his dues and his initiation fee, then he is a NEW member. For a PHSA member to get credit for a new member, it is recommended that the sponsor have the prospect fill out a membership application and put his, the sponsor, name at the bottom of the application. Office — namely, a service officer from one of the organizations — AmVets, American Legion, Veterans of Foreign Wars, or Disabled American Veterans. If you need verification on your claim for pension or compensation dating back to December 7, 1941, send a notation to be placed in the PH-GRAM. Also, check to see if you have your beneficiary up-to-date, so your wife, daughter, son, sister, brother, mother, or father may benefit at your death. Be sure to use your C-Number, full name and address on all V. A. contacts.
