

# CONGRESSIONAL MEDAL OF HONOR DONALD KIRBY ROSS

"For distinguished conduct in the line of his profession, extraordinary courage and disregard of his own life during the attack on the Fleet in Pearl Harbor, Territory of Hawaii, by Japanese forces on 7 December 1941.

When his station in the forward dynamo room of the USS NE-VADA became almost untenable due to smoke, steam, and heat, Machinist Ross forced his men to leave that station and performed all the duties himself until blinded and unconscious. Upon being rescued and resuscitated, he returned and secured the forward dynamo room and proceeded to the after dynamo room where he was later again rendered unconscious by exhaustion. Again recovering consciousness he returned to his sta-

tion where he remained until directed to abandon it."

The original Citation was signed by Franklin Delano Roosevelt. Medal and Citation were presented, April 1942, at Pearl Harbor by Admiral Chester Nimitz.

Captain Donald Ross's Navy career was spent in many areas of activities and accomplishments. From his enlistment days, June 3, 1929, in Denver, Colorado, becoming Company honor man in recruit training to later assuming additional duties as an Aide to President Truman.

A few of the ships Captain Ross saw duty aboard were the USS Henderson, USS Relief, USS Brandt, USS Argonaut, USS Simpson, USS Minneapolis, USS Platte and USS Kearsarge.


# TWO OKLAHOMA SURVIVORS REUNITED

There was a lot of reminiscing going on recently when Joe Szewerenko, Route 1, Chebanse, Illinois, located Leonard Kelly, 212 Berkley Avenue, Battle Creek, Michigan.

The two were aboard the USS Oklahoma at Pearl Harbor and until recently didn't know the other had survived the ordeal.

How did they find out about the other — via the Pearl Harbor-GRAM.

Samuel Kronberger was a navy veteran of thirty-five years. He enlisted in the National Naval Volunteers at Boston in January 1907 and immediately saw duty aboard the gunboat USS Gloucester and the USS Kearage. He was released from active duty in 1917 but was immediately recalled and reported aboard the USS Nebraska.

Sam was a member of the boarding crew that seized the German liner Crown Princess Cecelia. Later, he served aboard the USS McCook, a destroyer.

On December 7, 1941, Edward and Robert Kronberger were serving aboard the USS West Virginia with their father, Sam, when the attack took place. Sam was blown off the ship by the bombs.

The Loyalty Day parade in Gardena, California, which is held each year, is due to the untiring efforts of Sam, who was known to everyone in the community as "Navy Sam Kronberger."

Sam Kronberger was the founder of the Pearl Harbor Survivors Association, founded in 1958. Edward and Robert were of the original founders.

In 1960, Sam was honored as "Veteran of the Year" and was presented an award by all the service organizations of Gardena at the General Rosecrans V.F.W. Post Memorial Hall on Veterans Day, Nov. 11th.

All of Sam's four sons, Edward, Robert, William and Richard, followed in his footsteps by becoming Navy men and making it their career. His daughter, Dorothy, married a Navy man, Chief Warrant Officer Howard Kamler.

Sam was Civil Defense director of Gardena and was active in many civil organizations up to the time

of his passing on September 5, 1961, at the Naval Hospital, Camp Pendleton.

Edward Kronberger retired from the naval service after 30 years. His present address is: 6217 S. St. Andres Place, Gardena, Calif. 90247.

Robert S. Kronberger (LCDR) will retire December 1970 with 37-years naval service. His present address is: 14928 Mariposa Avenue, Gardena, Calif. 80247.

William was in the process of re-enlisting back in the States when Pearl Harbor was attacked. He retired after 30-years of naval service and resides at: 9051 Ronda Avenue, San Diego, California.

Richard was in the Philadelphia Naval Shipyard, December 7th, 1941. He retired after 30-years of naval service and is residing at: 2114 W. 160th St., Gardena, Calif.

Dorothy and her husband, who retired after 24-years of naval service, resides at: 2119 W. 160th St., Gardena, Calif.

#### ANNUAL FINANCIAL STATEMENT

To: National Executive Board

Pearl Harbor Survivors Association, Inc.

Gentlemen:

I have examined the attached Statement of Financial Condition as of December 31, 1969, and the Statement of Cash Receipts and Disbursements of the Pearl Harbor Survivors Association, Inc., for the twelve months ended December 31, 1969. My examination was made in accordance with generally accepted auditing standards and included such auditing procedures which I considered necessary in the circumstances. I examined and reported upon the financial statements of the Association for the previous year.

The year of 1969 shows an increase in Surplus and Reserve for Life Membership of \$8,572.37. Membership also increased during 1969 from 3007 members to 3384, which is an increase of 12.5%. During 1969 life members (included in above amounts) increased from 1060 to 1218, which is an increase of 14.9%. The \$8,572.37 increase in Surplus and Reserve for Life Membership is a substantial gain over the \$4,130.99 for the year 1968, but is needed to cover future expenses for the increasing

numbers of Life members.

In my opinion, the aforesaid financial statements present fairly the financial position of the Pearl Harbor Survivors Association, Inc., at Decemper 31, 1969, and the results of its operations for the year then ended, in conformity with generally accepted accounting principles applied on a basis consistent with that of the preceding year.

In 1963 I assisted in the National Convention held in St. Louis as the floor manager. In 1964 I successfully conducted a Missouri State Convention.






