

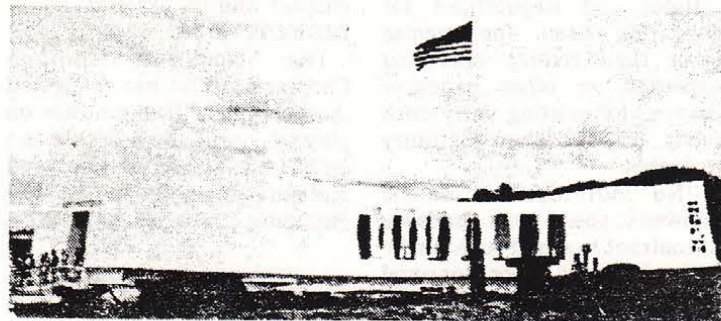

DECEMBER 7, AT PEARL HARBOR

President Gerald R. Ford places wreath aboard the USS Arizona Memorial at Pearl Harbor during services on December 7, 1975, with PHSA members from the Aloha Chapter looking on: John E. It was a clear, sunny morning at Pearl Harbor, and aboard the stark white USS Arizona Memorial a low tide made it easy to look over the side and see the deck of the battleship Arizona, former flagship and grim reminder of World War II.

It was here that President

Gerald R. Ford joined more than 200 people, representing the military and civilian communities, to pay his

respects to the thousands of Americans who lost their lives in the flaming holocaust that signalled the United States'

entry into World War II.

The time was 7:55 a.m., December 7, the exact time and date of the Japanese attack on Pearl Harbor in 1941.

"We will hold our course for a peaceful Pacific," the President said during his brief address, "remembering that vigilance, the price of liberty, must be paid and repaid by each generation. We will keep faith with our past as we work to build a better world for our children and our grandchildren. I believe they will see peace come true and thank us, as we thank those fallen heroes we honor here today. There duty is done, let us do ours."

The President also presented his personal wreath, made up of white carnations and bearing

NATIONAL DIRECTIVES AND RESULTS OF VOTING

DIRECTIVE NO. 24-75:

New Jersey Chapter No. 1 to be allowed to sell existing supply of blazer patches.

DIRECTIVE NO. 25-75:

New Jersey Chapter No. 1 requests permission to reproduce association's seal to be used on 1½" gold medallion for the Ladies Auxiliary of New Jersey Chapter No. 1. The reverse side to have "Ladies Auxiliary, New Jersey State Chapter No. 1" inscribed around the U.S.S. Arizona.

DIRECTIVE NO. 26-75:J

Alabama Chapter No. 1 requests permission to reproduce association's seal on ball point pens to sell at about \$1.00.

DIRECTIVE NO. 28-75:

Illinois Chapter No. 1 requests permission to make association's seal plaques (wood, about 14"x1½"). Plaques alone — \$22.10, with electric clock installed — \$26.90.

DIRECTIVE NO. 29-75:

The book "One Sunday Morning" to be advertised in the January 1976 issue of the GRAM. Balance of books to be disposed of December 31, 1976.

Rules and Regulations for monies other than routine operating expenses, or other expenses covered by existing petty cash funds, or other than statutory expenses.

"No individual is to be allowed to spend Assn. funds, or to contract to spend such funds, without getting prior approval from the Treasurer, and then getting a written quotation. The Treasurer shall then get approval of the Executive Board.

It must be clearly understood that any person who does not follow this procedure will be personally responsible for any debt or bills so incurred."

DIRECTIVE NO. 31-75:

The Golden State Chapter of California requests permission to use the Pearl Harbor Emblem on small flags. The

proposed size of the flags will be 4"x6", 5"x7", 8"x10" and 10"x12". These flags will be sold at a nominal fee for the purposes of helping to defray the cost of operating the chapter and its projects.

DIRECTIVE NO. 32-75:

The Northern Indiana Chapter of PHSA has requested the use of the PHSA emblem on playing cards with either an emblem centered on the card and surrounded by the Service emblems, much like the PHSA

decanter or just the PHSA emblem. They advise they are negotiating for the best "deal".

DIRECTIVE NO. 33-75:

Shall Texas Chapter No. 5 be permitted to sell jackets with Embroidered Emblems, similar to Northern Indiana Chapter No. 2 emblems. Price

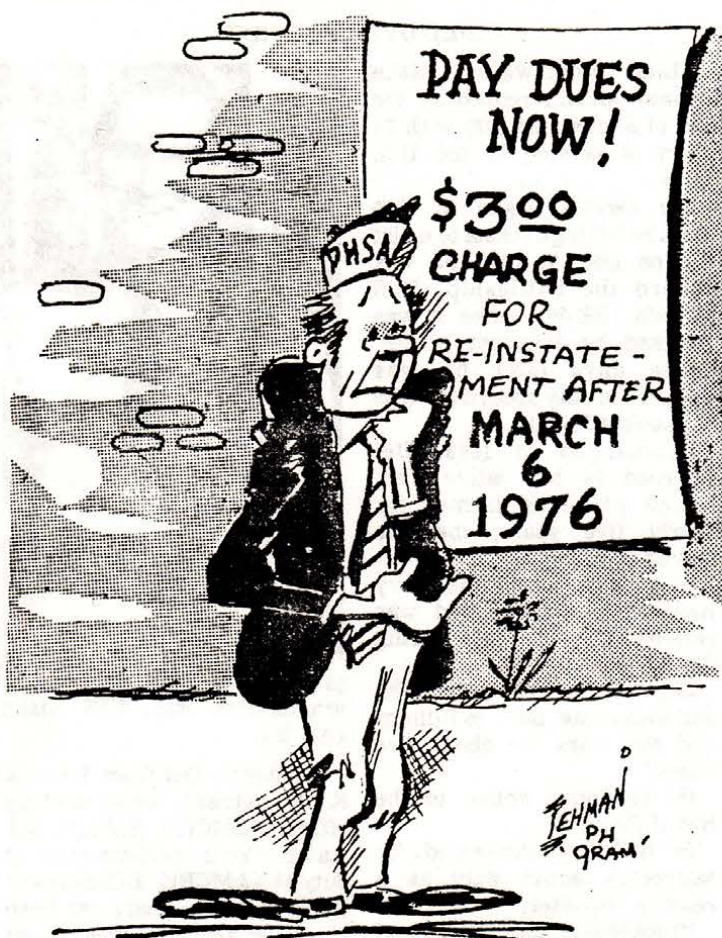
United States Government and other groups that PHSA is a bona fide association working towards patriotic, historical and educational purposes.

REINSTATEMENT FEE ON DELINQUENTS

Have you mailed your 1976 annual dues of \$6.00 to the National Treasurer, PHSA, P.O. Box 106, McLean, VA 22101? If not, do it soon!

Any member who has been dropped for non-payment of dues will be subject to a \$3.00 Reinstatement Fee effective March 6, 1976.

Members who have been dropped for non-payment of dues previous to 1975 will, also, be subject to the \$3.00 Reinstatement Fee.

COST OF BOOSTERS AND ADS INCREASED

The National Executive Board, meeting in Houston, Texas, this past October, approved of the new prices for boosters and ads in the Pearl Harbor-GRAM which are currently in effect.

Boosters—a 5-line maximum booster is \$7.50 for a one-time printing and \$25.00 for four consecutive printings. Boosters will not be used for advertising.

Advertisements—a full page ad is \$250.00 for one printing, \$800.00 for four consecutive printings—half page ad is \$175.00 for one printing, \$560.00 for four consecutive printings—quarter page ad is \$100.00 for one printing, \$320.00 for four consecutive printings—1 column, 1 inch ad is \$15.00 for

one printing, \$48.00 for four consecutive issues—1 column, 2 inch ad is \$28.00 for one printing, \$88.00 for four consecutive printings—1 column, 3 inch ad is \$39.00 for one printing, \$124.00 for four consecutive printings—2 column, 1 inch ad is \$28.00 for one printing, \$88.00 for four consecutive printings—2 column, 2 inch ad is \$48.00 for one printing, \$152.00 for four consecutive printings—2 column, 3 inch ad is \$66.00 for one printing, \$212.00 for four consecutive printings.

There will be an additional charge for ads to appear on a designated page in the GRAM and if changes are to be made in consecutive printings.

Payments for boosters and advertisements must be made in advance of printing in the GRAM.

Billeted at the Court of Flags Hotel Resort from October 23-27th, more than 150 survivors started the convention-reunion in the way that only survivors can. War stories and old memories were relived in a memorable way.

Our national president, Joel Bachner, and his wife, Muriel came from New York to attend the convention-reunion. The Naval Training Center had named the graduating 337th Recruit Brigade in honor of the Pearl Harbor Survivors. NP Bachner was the reviewing officer and guest speaker.

Two business meetings were held, one for state chairmen and chapter officers, and one for the general meetings. With NP Bachner in attendance many questions and items of interest were presented for comment and consideration.

While the survivors were busy in meetings, the women were taking in the many attractions that abound in the Orlando area.

Guest speaker at the evening's banquet was Captain Glenn R. Cheek, commanding officer of the Orlando Naval Station, tracing the history of the U.S. Navy over the years to present days. 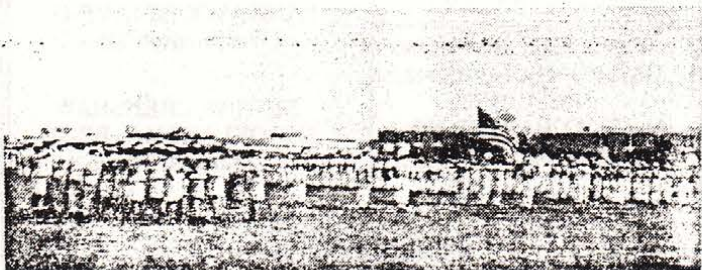
Past NP Shane with an award. Those attending the banquet were presented leis and orchids from Hawaii. Concluding the events of the evening was ballroom dancing.

PIPED OVER THE SIDE!

Chief Boatswains Mate Delmar Martin retired at the end of September 1975 with 31 years of service in the U.S. Navy.

His service began in 1939 when he left high school to enlist and on Dec. 7, 1941, he was aboard the battleship, USS Nevada (BB-36), when it was attacked by Japanese planes. Three days later he was assigned to duty aboard the USS St. Louis (CL-49).

Discharged in 1945, Del returned to his native Tennessee where he farmed for nearly five years, then he moved to Montana.

In 1950 he joined the Navy Reserve in Billings and was recalled to active duty during the Korean Conflict.

Del "put in about 18 months and then came back to Billings and sold cars for about five years."

He remained active in the Naval Reserve.

In 1962 he volunteered for temporary active duty as a reserve recruiter.

"I got to stay here as long as I did because I served only for periods of six months. If I didn't make an assigned quota, my tour was ended. I was lucky enough to keep my quotas."

Del and his wife, Betty, reside at 122 Burlington Ave., Billings,

Montana 59101. They have two children, a daughter, Mrs. Carolee Bathurst, and a son, David, who enlisted in the Navy, this past June and is presently serving aboard the ammunition ship, USS Kiska (AE-35).

MEET OUR CARTOONIST

Clark has been drawing cartoons since he was able to hold a pencil. Then he tells me, "I have had my stuff published by papers and magazines since about 14 or 15 years of age."

Nowadays, he sticks to doing editorial cartoons. Besides doing cartoons, Clark has been in sales promotion most of his life mainly in the Southeastern States but for awhile in the Colorado, Wyoming and Utah area.

Clark entered military service at Fort Bragg, NC, on July 10, 1941. Took his basic training at Fort Belvoir, VA (Corps of Engineers) and upon its completion in October 1941 was shipped to Schofield Barracks, Hawaii.

Upon his arrival there October 17th, he became a part of the newly activated 34th Engineers, "C" Regiment, serving with Headquarters and Service Company.

Prior to the attack on

December 7th, Clark stated "I was assigned to help cut the Waikane Trail operating an ancient Allis Chalmers' bulldozer." Then he went on detached service with a provisional engineer group which was attached to the 7th Division and took part in the landing at Kwajalein in the Marshall Islands in early 1944.

In May 1944, he returned to Hawaii just in time to rejoin his old outfit for the landing at Saipan, in the Marianas, in June. This time his outfit was with the 27th Division.

Then in 1945, he returned to the States and received his honorable discharge at Fort Devens, Massachusetts, in September.

Today, Clark and his wife, Sylvia Settlemire, reside at: 1029 - 12th St. Drive SW, Hickory, NC 28601. They have one son, Clark, Jr., who has just finished college and received a degree in education.

the inscription "In Memoriam, December 7, 1941."

Admiral Maurice F. Weisner, Commander-in-Chief, Pacific Fleet, presented the Navy wreath and General McLaughlin presented the Marine Corps wreath.

Floral tributes were then placed by all other organizations, making a total of 34 wreaths, the most ever presented at the annual observance.

The next presentation, in order, was the Pearl Harbor Survivors Association's wreath by Kenneth W. Murray, president of the Aloha Chapter and Fred Garbuschewski, state

chairman of Hawaii.

Immediately following the President's address came the attention to colors, with the Star-Spangled Banner beautifully rendered in four-part harmony by trumpeters from the Pacific Fleet Band.

Mrs. Ford, Governor and Mrs. Ariyoshi, Senator and Mrs. Hiram Fong and Congressman Sparky Matsunaga were distinguished guests.

Fred Garbuschewski represented PHSA's national president, Joel E. Bachner, at the memorial services. A flag that was raised and lowered at 0900 on the 7th of December 1975 on the Arizona Memorial was presented to Fred by the Arizona Memorial Narrator, Fred K. Kukonu.

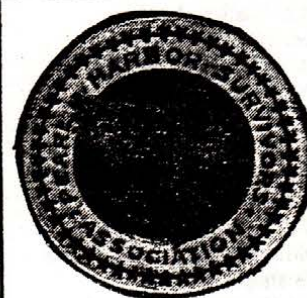

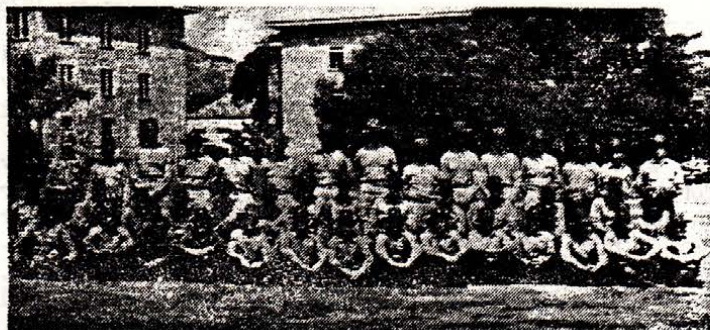

**SURVIVOR SCATTERS
ROSES DECEMBER 7th**

At 12:55 p.m. (NY time) — the anniversary of the 7:55 a.m. attack in Hawaii on Dec. 7, 1941 — a Pearl Harbor Survivor, Joseph Hydrusko (left), and his pilot, Red Stevenson (right), led a covey of antique planes out of Sahns Airport in Amityville (NY) to drop 34 red roses over the Statue of Liberty. They circled the stae at 700 feet in their open-cockpit biplane, a blue and yellow Waco VPF-7. At exactly the right moment, Hydrusko released the eight-foot-long red, white and blue streamers that carried the red roses to Liberty Island.

Hydrusko, a 56-year-old restaurateur, was a chief

boatswains mate on the USS Solace (AH-5), a hospital ship, in Pearl Harbor. When the battleship, USS Oklahoma (BB-37) capsized, Hydrusko and a Navy Yard worker went on the ship, and, responding to trapped sailors who tapped out SOS calls on compartment walls, they brought 24 men out alive. His heroism has brought him many medals and awards, including the Navy Commendation Medal.

The Statue of Liberty Chapter (NY) held their memorial services at the U.S. Merchant Marine Academy in Kings Point with a formation of six planes of the Antique Airplane Association in a fly-over.

MEMORIAL SERVICES AT UNIVERSITY OF ARIZONA

Barton O. Simpson (USS Oglala) was the emcee at the Twenty-second Annual USS Arizona Memorial Service, Student Union Hall, University of Arizona, on December 7, 1975, sponsored by the University of Arizona, Southwest Region Fleet Reserve Association and the Tucson Council Navy League of the United States.

Albert C. Burrows, USN Retired.

MEMORIAL SERVICES IN OKLAHOMA

The Oklahoma PHSA Chapter members and the Fleet Reserve in Oklahoma City had a joint memorial service at the Anchor of the USS Oklahoma in downtown Oklahoma City, December 7th, commemorating the December 7, 1941, attack on Pearl Harbor.

PEARL HARBOR WEEK

The Governor of the State of Michigan, William G. Milliken, presented this Executive Declaration in observance of December 7-13, 1975 — REMEMBER PEARL HARBOR WEEK . . .

"On Sunday, December 7, 1941, Japanese naval forces launched a successful surprise attack upon the United States at Pearl Harbor, Hawaii. By the next day, America was in World War II.

More than two thousand American servicemen died in battle that day. Many are still entombed in the sunken battleship, USS ARIZONA, and a national shrine now stands above that ship in Pearl Harbor.

History notes that the memory of Pearl Harbor

galvanized American public opinion and that a tactical defeat became the springboard for strategic victory. The memory taught America the bitter lesson that she must always be prepared to meet a military challenge.

The intervening years have clouded the memory of this sad experience for many — but not for all. Among those for whom the memory is still vivid are the members of the Pearl Harbor Survivors Association. Their motto, "Remember Pearl Harbor," should be with us each year at this time as we pray there will never be a repeat of this event.

Therefore, I, William G. Milliken, Governor of the State of Michigan, declare the week of December 7-13, 1975, as Pearl Harbor Week and urge all citizens to reflect on the sacrifices made by our countrymen early on a Sunday morning 34 years ago. I further urge all churches and synagogues to offer appropriate thanksgiving and recognition of that sacrifice on behalf of our country.

Given under my hand on this nineteenth day of November in the year of our Lord one thousand nine hundred seventy-five and of the Commonwealth one hundred thirty-ninth.

IDAHO OBSERVES DECEMBER 7TH

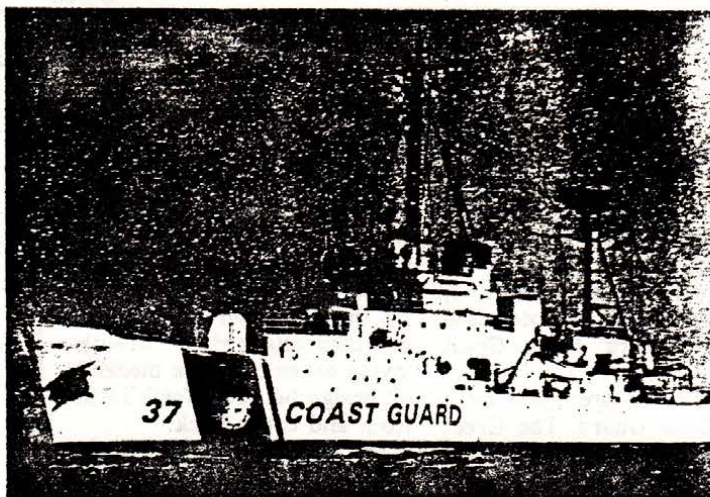

MEMORIAL SERVICES ABOARD USCGC TANEY

The U.S. Coast Guard in Tidewater, Virginia, paid tribute to 2,100 personnel who lost their lives in service to their country at Pearl Harbor, December 7, 1941.

Members of PHSA Tidewater Chapter No. 2 with their families and friends attended the memorial services aboard the USCGC TANEY (WHEC-37).

The memorial service was conducted by Lt. Benner, Chaplain, Fleet Religious Support Activity, U.S. Atlantic Fleet.

A Marine Rifle Squad from Camp Elmore rendered a 3-gun volley and a bugler sounded taps, with CINCLANTFLT Band providing musical selections during the services.

The memorial wreath was furnished by the PHSA Tidewater Chapter.

Arthur L. Scott (2nd Engineers Bn., U.S. Marine Corps) is the chapter president and Harry Hopkins (USS St. Louis) is the state chairman.

The U.S. Coast Guard Cutter TANEY is a unique and historic vessel — she is one of only two ships still in commission (and the only one still on active duty; of the 101 fighting ships present during the Japanese attack on Pearl Harbor, December 7, 1941. She was the first vessel to bring her guns to bear on the enemy aircraft.

(The other ship in commission is the U.S.S.S. ARIZONA, lying on the bottom of Pearl Harbor and run as a memorial to those who died in the attack.)

The TANEY, now stationed at Norfolk, VA, was christened at

the Philadelphia Navy Yard, June 31, 1936. She still steams at her designed speed (20 knots) with the original boilers and steam turbines.

The TANEY has served with distinction in three wars — World War II as an antisubmarine escort and later as an amphibious flagship (with special communications facilities); the Korean War as a support ship manning ocean weather stations, and during the Vietnam war performing naval gunfire support and preventing infiltration of enemy troops and supplies.

Today, the TANEY and her crew of 13 officers and 131 enlisted men perform a variety of tasks in the North Atlantic — enforcing U.S. fishing laws, protecting lives and property at sea, and protecting the marine environment.

MINNEAPOLIS OBSERVES SUNDAY, DECEMBER 7TH

The Greater Minneapolis Chapter of Minnesota held their memorial services on Sunday, Dec. 7th, at the Fort Snelling Memorial Chapel in the historic Fort Snelling State Park with Dr. Clifford Nelson conducting the services.

Al Quackenbush (USS Tangier) read the Governor's Proclamation for Pearl Harbor Sunday.

USS TUCKER (DD-374)

The destroyer USS TUCKER (DD-374) was built by the Norfolk Navy Yard, Norfolk, VA. Her keel was laid August 15, 1934, launched on February 26, 1936, and commissioned on July 23, 1936.

The TUCKER was lying in a nest of five destroyers alongside the tender USS Whitney (AD-4), undergoing a tender overhaul, when the Japanese launched their raid on Pearl Harbor, Dec. 7, 1941.

The Japanese planes were first sighted as they began their dives on the battleships, and even before the general alarm could be sounded, one man had begun firing the after machine guns. Two minutes later the after 5-inch guns were firing at the enemy, while the engineering gang worked feverishly to reassemble machinery torn down for the tender overhaul.

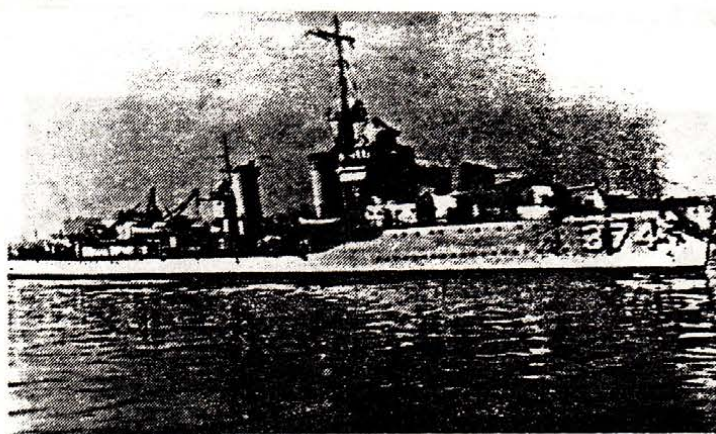
At 0810 the main battery opened up on high flying planes, firing for half an hour. Fifteen minutes after the order to cease fire, another wave of aircraft came over, followed at 0905 by several dive bombers coming in low from all sides. During this time TUCKER registered hits on three planes, two of which crashed on a hill in flames. The other disappeared over a low ridge, smoking and flaming badly. The last group approached from the north at 0917 and two minutes later the attack was over.

CALIFORNIA'S PHSA BOWLING TEAM

After Pearl Harbor, USS TUCKER spent time on convoy duty between Pearl Harbor and San Francisco, escorted ships to Suva, Fiji Islands and to the New Caledonia, Sydney and Melbourne, Australia, and to Auckland, New Zealand.

On August 1, 1942, TUCKER was ordered out on her last mission, escorting SS Luckenbach from Suva to Espiritu Santo.

TUCKER had just transited Bruat Channel and was swinging to enter Second Channel, Espiritu Santo, on 3 August when she struck a newly-planted mine amidships and broke in half. The main

deck amidships buckled and immediately submerged under about six feet of water.

With all power lost, the ship drifted helplessly until being taken in tow by YP-346. When the YP had gone as close to the beach as she dared, the tow line was cut and an anchor let go. When the ship stopped settling the commanding officer returned to his ship and cut the anchor chain. A motor launch then took the ship in tow and after about two hours managed to beach her in ten fathoms of water. Three men were listed as missing and three were killed in the sinking.

USS TUCKER (DD-374) earned one Battle Star on the Asiatic-Pacific Area Service Medal for the Pearl Harbor Raid, 7 December 1941.

TUCKER's overall length was 341 feet, beam was 35 feet, displacement was 1500 tons and her speed was 35 knots.

ATTENTION TO ALL FLYERS!

Were you able to get airborne on December 7, 1941?

Bert C. Payne was with VP-23, Ford Island, on that 'infamous day'. His PBV with crew was one of the few aircraft that was able to get off the ground. The pilot, Commander Winters, executive officer of VP-23, was killed a short time later while taking off from Pearl Harbor on a return flight to the mainland.

Regardless as to where you were on duty, we are interested in finding the pilots and crew members of aircraft that were able to get airborne that day.

It would be interesting to know where each man took off, what outfit he was with, what he flew, when he returned and what difficulties he encountered.

Bert tells me that he is not an organizer, however, if anyone who was in the air on that day is interested, he would start pulling the group together. His address is Route No. 1, Box No. 10, Garden Valley, California 95633.

Bert went on to tell me, "Basically, I feel and I hope each one feels, that as soon as we were airborne, our minds were aware of a single purpose backed by a feeling in our hearts that this was for real — a challenge to our peace-loving way of life."

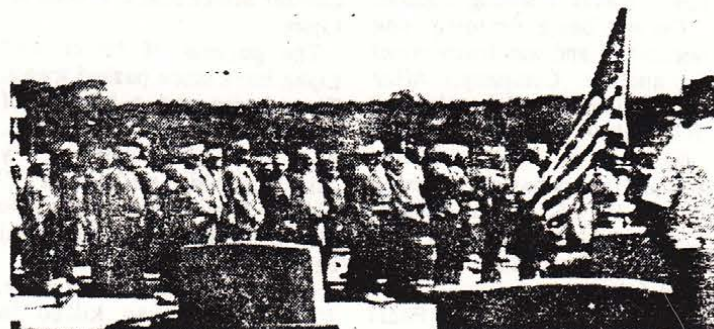

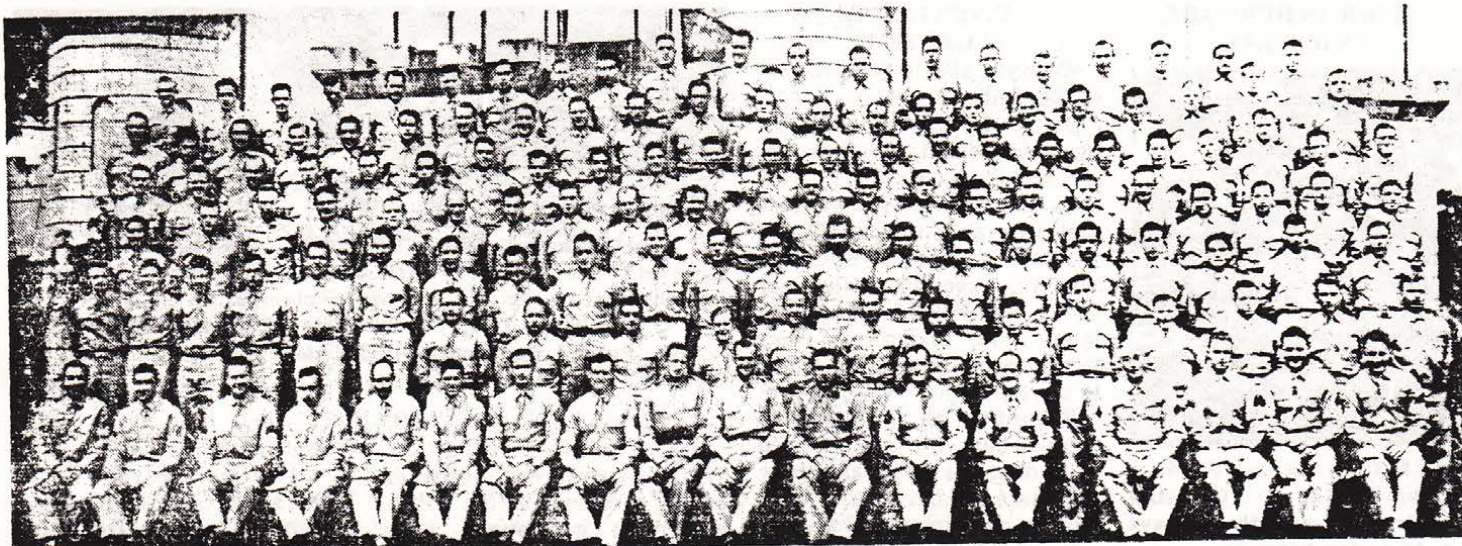

One day, back in November 1940, four youths, who grew up and went to school together in Detroit, Michigan, joined the U.S. Navy. They took their basic training at the Great Lakes Naval Training Station.

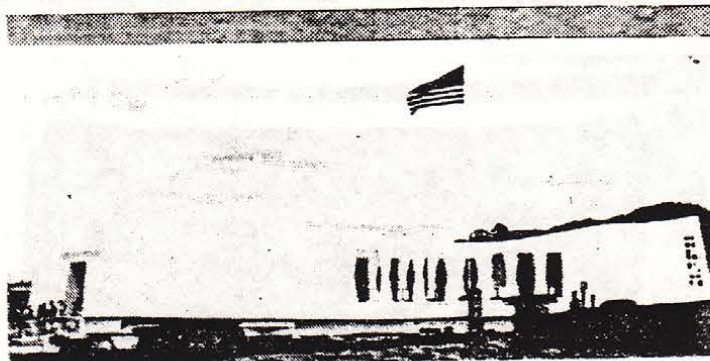
During basic training one became ill and was transferred to another Company. After completing his training, he was assigned to the USS Nevada (BB 36). A second youth, after completing his basic, requested duty on the USS Helena (CL-50) to be with his older brother. The other two were assigned to the USS Arizona.

All four men were at Pearl Harbor on December 7, 1941. The first, Byrl King (USS Nevada), now lives in the state of Oregon and is a member of PHSA. The second, Charles W.

McClelland (USS Helena), is the present Motor City (MI) Chapter's secretary-treasurer. The other two were both killed on the USS Arizona (BB-39) on December 7, 1941. They were Chester Miller and Clarence W. Lipke.

The parents of Miller and Lipke have since passed away. Two sisters and a brother of Clarence still live in Detroit. They are Dorothy Smith, Mary Alice Oswald and Robert T. Lipke. They were invited to attend the Michigan Memorial Service, Dec. 7, 1975.

An older brother of Clarence, Nicholas J., was killed in France during World War II. The Lipke Recreation Center, located on the east side of Detroit, was named in their honor.

NOVEMBER 11TH — VETERANS DAY RESTORED

The Senate and House has passed a bill and it has been signed into law by President Ford, restoring November 11th as Veterans Day on a national basis. The law becomes effective January 1, 1978.

November 11th is almost a national day of observance now, with the states — Hawaii, Nevada, Rhode Island, Utah — and the District of Columbia continuing to observe Veterans Day on the fourth Monday in October. It was congressional action in 1968 to create Monday holidays that moved Veterans Day from its traditional November 11th date. Oklahoma was the only state at the time refusing to make Veterans Day a Monday holiday.

Georgia Veterans Service Director Pete Wheeler said he is glad "Washington finally is seeing the light." He added, "Without question, November

11th is the only appropriate date for the observance of Veterans Day. Changing it to any other date only serves to cloud its true significance."

Wheeler said "The so-called 'Monday Holiday Bills' do exactly what they were meant to do — create long weekends. The true meanings of the holidays themselves become lost in the shuffle of commercialism."
