

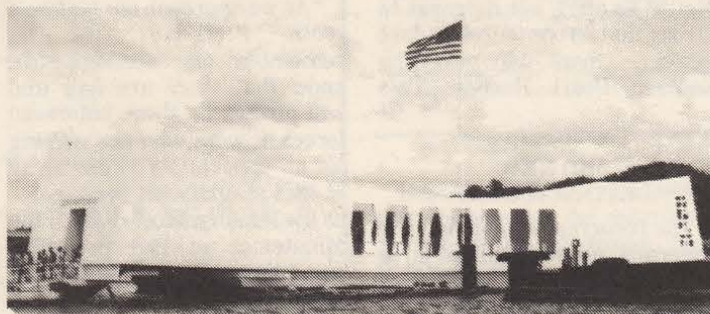

SEATTLE CHAPTER AWARDS

Chapter No. 2 of Seattle, WA, awarded 20 Educational Assistance Awards to survivors' descendents of the chapter and one award to a survivor member in helping to further their college educations.

William C. Phillips, chapter president, tells us, "Many wonderful letters were received from the recipients which were most gratifying. This is the second time in recent years that the chapter has made these awards. It is one of the ways to which the Seattle Chapter is helping to keep alive the motto — "Remember Pearl Harbor — Keep America Alert."

"We had mailed a questionnaire to the Seattle Chapter members requesting students' name and college that they were attending and the survivor's name. These were mailed to our Educational Assistance Awards Committee and they met with the executive board and we finalized our payment plan for the students. The checks were given to the members or mailed to the students on November 14, 1975 at our regular business meeting.

"The Educational Assistance Awards were checks of equal amounts sent to each student and the one survivor out of our Educational Assistance Special Savings Account for this purpose.

"We have built this fund up through some raffles, rebates

The below letter was received from H. F. Garbuschewski, Hawaii State Chairman, and is printed herewith for your information.

DUTY IN TH OLD NAVY!

The USS Constitutions ("Old Ironsides") as a combat ship carried 48,600 gallons of fresh water, sufficient for six months at sea (no evaporators).

August 23, 1797, she set sail from Boston carrying 474 officers and men, 48,000 gallons of fresh water, 7,400 cannon shots, 11,600 pounds of black powder and 7,000 gallons of rum. Permission given to harass and destroy the English.

October 6, Jamaica, she took on 620 pounds of flour and 68,300 gallons of rum.

She then headed for the Azores, arriving there on November 15. Provisioned the ship was 500 pounds of beef and 4,300 gallons of Portuguese wine. On November 18, she set sail for England.

In the ensuing days, she defeated 5 British Men-of-War, captured and scuttled 12 England merchant ships, salvaging only the rum. By January 27, her powder and shot exhausted, she made (unarmed) a night raid at the Firth of Clyde. The landing party captured a whiskey distillery and transferred 40,000 gallons aboard by dawn. She then set sail for home.

The Constitution arrived in Boston in February 1798. Supplies aboard: no cannon shot, no powder, no food, no rum, no whiskey, no wine, and 48,000 gallons of stagnant water! (taken from Pine Tree (ME) Chapter February 1976 Bulletin.)

unified America determined with an effort never seen in the history of the world. We must never relax that determination. We must forever keep our Nation so alert, our defenses so strong that no one will ever dare again — there will never be another Pearl Harbor. This

NO NEW
GI INSURANCE

The recurrent rumor that the Veterans Administration is to pay a new GI insurance dividend has been denied by the agency.

"A false and misleading rumor is still plaguing us at the Veterans Administration and leading veterans to request dividends on GI insurance based on World War II service," a VA spokesman said.

"Congress has not passed a law giving all World War II veterans a dividend on GI policies. We have not requested veterans to write us regarding such a dividend. The story that we have is a hoax.

"The only dividends that we are currently paying are to World War I and World War II veterans who have kept their government life insurance in force. These dividends are paid routinely on an annual basis and no application or request is necessary. There is none other. There will be none other."

The VA said the special GI insurance dividend paid in 1948, apparently has bred false hopes that another one is in the works.

the USS Arizona Memorial Boating Landing adjacent to Halawa Gate at Pearl Harbor. These are free.

You may line up for the Memorial Tour beginning at 9 a.m., and the boat operates until 3:30 p.m., Tuesday through Sunday, continuously. The boat also operates on five national Monday Holidays (Washington's Birthday, Memorial Day, Labor Day, Columbus Day and Veterans Day), on Inauguration Day, Fourth of July and December 7th, when they fall on Monday. There is no service on any other Monday or on Thanksgiving, Christmas or New Year's Day.

You may sign up for the Pearl Harbor tour in person at the boat landing information office beginning at 8 a.m. for the cruises scheduled that day. The tour is a one-hour narrated boat tour of Pearl Harbor and takes in Battleship Row, the shipyard destroyer piers, submarine base, and the Arizona Memorial. The Harbor Boat Tour operates Tuesday through Saturday, except national Monday holidays and Tuesdays following national Monday holidays. Tours leave five times daily: at 8:30, 9:30 and 10:30 a.m. and 1:30 and 2:30 p.m. Advance reservations are not accepted. Periodically, the 10:30 a.m. tour is utilized for special youth groups.

The rules for your visit are:

children must be at least six years of age; children under 12 must be accompanied by an adult; an adult supervisor 21 years of age or older is required for every five children; footwear is required; bathing suits are now allowed; and photography is permitted.

Additionally, on the first Saturday of each month from 12 to 4 p.m. a Navy ship is open for general visiting at Pearl Harbor. This "Open House" is subject to change. Information may be obtained by calling 471-3460 (if on Oahu). Address inquiries to: Public Affairs Officer, Fourteenth Naval District, Box 110, Code 007, FPO San Francisco 96610.

We receive questions about the Memorial and why can't the Navy do this or do that. In as little space as possible let me provide you with a definite answer. The Navy never has been funded to operate the tours or keep up the facilities, inadequate as they are. The Public Affairs Office, Fourteenth Naval District, has been tasked with this added assignment of keeping the public informed. Not only that but the Public Affairs Office of Commander in Chief, U.S. Pacific Fleet is also very much involved.

First, the resolution is submitted to the individual's chapter for action, then sent to the respective state chairman for his approval or disapproval, state chairman forwards resolution to the respective district director for approval or disapproval. The district director will forward the resolution (original and three copies) to the Chairman of the National Resolutions Committee where the proposed resolution will be codified and prepared for presentation to the delegates when they register for the convention in Honolulu.

Where an individual is not a member of a local chapter, he shall so state in an accompanying letter with his resolution and submit it to the state chairman.

All resolutions that were submitted at the 1974 national convention in Anaheim and were not acted upon will be considered first at the 1976 national convention in Honolulu this December.

STATUE OF LIBERTY CHAPTER's MEMORIAL SERVICES



Sixty-nine survivors and their families attended Statue of Liberty Chapter (NY) No. 4's memorial services held this past December 7th at the U.S. Maritime Academy, Kings Point, New York.

Joining the survivors were fourteen color guards representing the Catholic War Veterans, Veterans of Foreign Wars, AmVets and their auxiliaries.

Participating in the service were chaplains of the three major denomination, the combined armed forces color guard detachment and firing squad.

The memorial wreath was blessed with water from the forward turret of the USS Arizona. A helicopter from the U.S. Army Reserve lifted the wreath and dropped it into Long Island Sound. As the wreath was dropped, a bugler sounded "taps" and the firing squad fired three volleys. The 26th U.S. Army band played several marches.

Following the memorial services, survivors and their guests had luncheon in the Officers' Club of the Academy.

1975 was an outstanding year for the Association and it is reflected in this Statement.

However, it was necessary to correct our Liability structure to show the Reserve for Life Membership, which had previously been carried as an Asset and so our Net Worth shows a considerable decrease. This is not a loss but an accounting change to show our Net Worth more fairly.

We also converted some of our investments to higher interest bearing certificates and so show \$9,848.61 as Interest Income.

Dear Jesse:

At your request for the Board of Directors of the Pearl Harbor Survivors Association, Inc., we have examined the balance sheet of the association as of December 31, 1975, and the related statement of income for the year then ended. Our examination was made in accordance with generally accepted auditing standards, and accordingly included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances; except we were unable to verify the deferred life membership dues from 1958 through 1963, since these records were destroyed in 1966.

In our opinion, except for the destroyed records on deferred life membership dues cited above, the accompanying balance sheet and statement of income present fairly the financial position of the association at December 31, 1975, and the results of its operations for the year then ended, in conformity with generally accepted accounting principles.

This engagement did not include the State and Local Chapters, nor the Offices of the District Directors, and we do not express an opinion on the financial position or results of operation for these organizations.

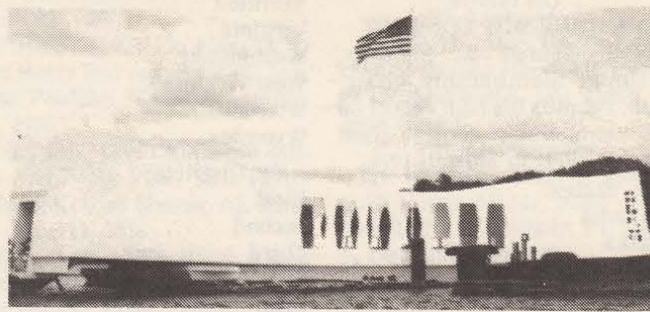

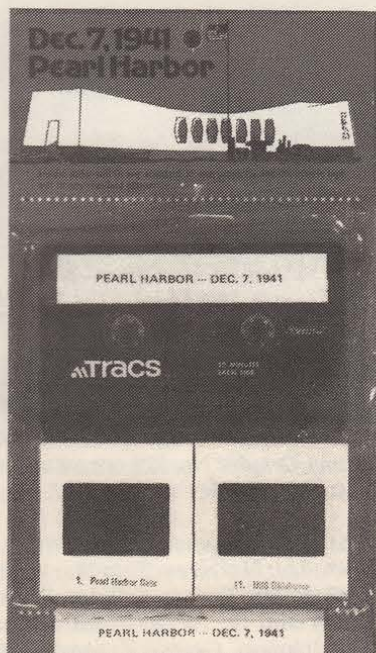

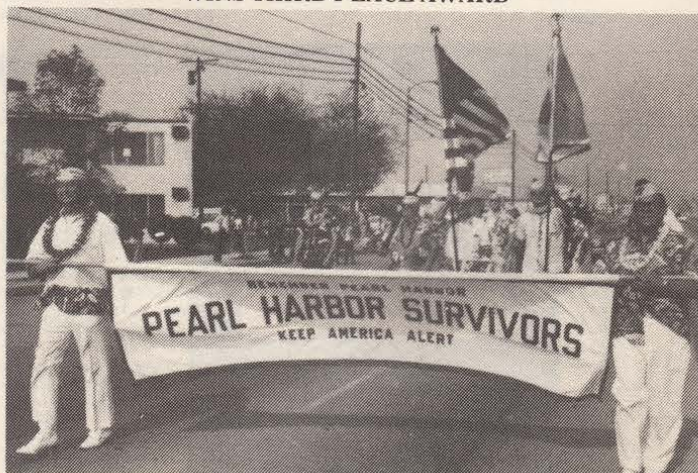

Homer and his wife, Frances, with their son, Larry, reside at 8497 300 Est., Oak Harbor, Washington 98277.

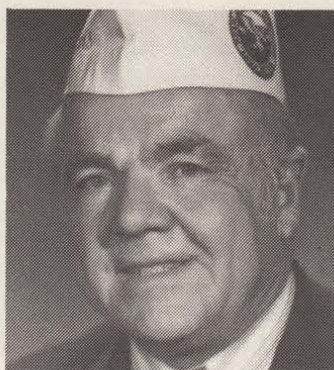
VAUGHN SEEKS RE-ELECTION AS 6TH DISTRICT DIRECTOR

In serving as the 6th DD for the past year and half, Charlie has visited all the states within his district except for two of them but he plans to visit them this year. He has visited various



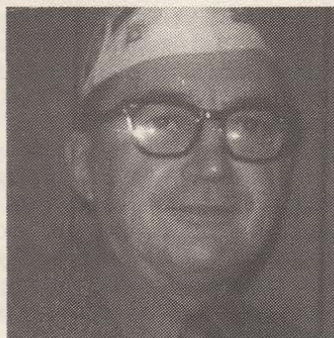

U.S.S. MARYLAND (BB-46)

The seventh state, Maryland, was admitted to the Union on April 28, 1788.

USS MARYLAND (BB-46), third ship of this name, was laid down April 24, 1917 by Newport News Shipbuilding Company and was commissioned on July 21, 1921.

With a new type seaplane catapult and the first 16-inch guns mounted on a United States ship, Maryland was the pride of the Navy.

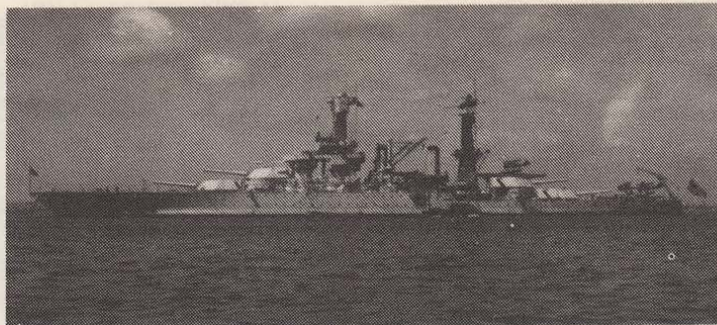
She appeared at Annapolis for the 1922 Naval Academy graduation and at Boston for the anniversary of Bunker Hill and the Fourth of July. In August-September she paid her first visit to a foreign port transporting Secretary of State Charles Evans Hughes to Rio de Janeiro for Brazil's Centennial Exposition. She made a good will voyage to Australia and New Zealand in 1925, and transported President-elect Herbert Hoover on the Pacific leg of his tour of Latin America in 1928.

MARYLAND was present at battleship row along Ford Island when Japan struck December 7, 1941.

A gunner's mate striker, writing a letter near his machine gun, brought the first of his ship's guns into play, shooting down one of the two attacking torpedo planes. Inboard of OKLAHOMA and thus protected from the initial torpedo attack, MARYLAND managed to bring all her anti-aircraft batteries into action. Despite two bomb hits she continued to fire and, after the attack, sent firefighting parties to assist her sister ships. The Japanese announced that she had been sunk, but December 30, battered yet sturdy, she entered the repair yard at Puget Sound Navy Yard.

She emerged from the Navy Yard on February 26, 1942 not only repaired but modernized and ready for great service. During the important Battle of Midway, the old battleships, not fast enough to accompany the carriers, operated as a backup force.

Assigned sentinel duty along the southern supply routes to Australia and the Pacific fighting fronts, MARYLAND and COLORADO operated out of the Fiji Islands in November



and advanced to the New Hebrides in February, 1943.

In the vast amphibious campaigns of the Pacific the firepower of MARYLAND and her sister ships played a key role. She gave support to one of the most gallant amphibious assaults in history, at Tarawa. She reduced pillboxes and blockhouses on Roi Island. On June 14, 1944 MARYLAND participated in the biggest campaign yet — silencing two coastal guns, she encountered little opposition as she delivered one devastating barrage after another. The Japanese attempted to strike back through the air. On the 18th, the ship's guns claimed their first victim, but four days later a Betty sneaked in flying low over the still contested Saipan hills and found two anchored battleships. Crossing the bow of PENNSYLVANIA, she dropped a torpedo which opened a gaping hole in Maryland's bow, portside. Casualties were light and in 15 minutes she was underway for Eniwetok, and shortly thereafter, to the repair yards at Pearl Harbor.

MARYLAND saw action in the aPalau Islands, Leyte Gulf, Surigao Strait, Okinawa, and other encounters.

In May, 1945, she entered the Navy Yard at Bremerton for an extensive Overhaul, then she entered the 'Magic Carpet' fleet . . . making five voyages between the West Coast and Pearl Harbor and returning more than 9,000 combat veterans to the United States.

On April 15, 1946 she entered the Puget Sound Naval Shipyard and was placed in commission in reserve on an inactive basis July 15th. She was decommissioned at

Bremerton April 3, 1947, and remained there as a unit of the Pacific Reserve Fleet.

MARYLAND was sold for scrapping to Learner Co. of Oakland, CA on July 8, 1959. She had received seven battle stars for World War II service.

On June 2, 1961, the Honorable J. Millard Tawes, Governor of Maryland, dedicated lasting monument to the memory of the venerable battleship and her fighting men. Built of granite and bronze and incorporating the bell of "Fighting Mary", this monument honors a ship and her men whose service to the Nation reflected the highest traditions of the naval service. This monument is located on the grounds of the State House, Annapolis, Maryland.

STATUS REPORT

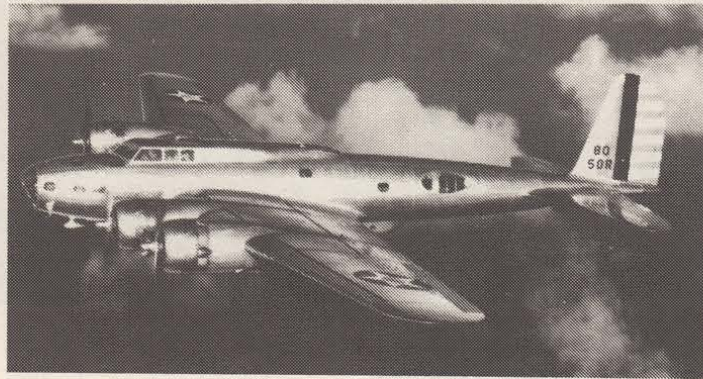
On March 8th, Bill Mizelle, PHSA National Capital Liaison in Washington D.C., spoke with the Senate Subcommittee that has our PHSA chapter bill before it for action.

Bill stated, "Action, if any, is now up to Robert Young, staff aide of the Senate Subcommittee on Federal Chapters, Holidays and Celebrations—the subcommittee that has been holding up our charter for several years."

The subcommittee may get a new chairman who may be Senator Strom Thurmond (R, S.C.). Bill's assessment of the new chairman is "that will not be any means assure success in getting Congress to give up the excuses to which it has clung for twelve years now since it last granted a charter to any applicant such as the PHSA."

Mr. Young told Bill that PHSA needs to get some political power—Senators and Congressmen—interested and backing our appeal.

"We have done that. Membership letters to Senators and Congressmen in the past twelve months have far exceeded the amount we have ever generated in the past. Some of these Senators and Congressmen (notably Rep. Ray Roberts, D. Texas) have gone to bat for us in the intervening months. Their efforts have had no visible effect" . . . William R. BERRY'S BOMBERS

(7TH AAF BRIEF,

Vol. 1, No. 33

Dated July 18, 1944)

Berry's Bombers (so-called for Maj. Ivan Andrew Barry, CO of a heavy bombardment squadron in the 7th AAF now operating from the Marshalls) have bombed a Jap aircraft carrier until it lay listing and aflame in the water, sunk a heavy Jap cruiser, scored bomb hits on another, scored bomb hit on a battleship, helped destroy two large tankers, helped sink a Jap transport, destroyed 15 Zeros in the air (liquidated an undetermined number on the ground), probably destroyed seven others, damaged 13 more and delivered untold bombloads to every Jap base that blocked their way from the start of the Solomon's campaign to the present.

This is the current war record of one of the oldest squadrons in the entire Army Air Forces, a squadron that came to Aug. 6, 1917, on a broad stretch of prairie land at San Antonio, Texas, just newly hacked out of the landscape and christened "Kelly Field." They called it the 50th Aero Squadron then and assigned 149 EM to function without an officer until Aug. 28, when Maj. Patrick Frissel became the first CO.

On Jan. 24, 1918, they landed in Liverpool, England, and proceeded to relieve a British Aviation Field Squadron at Harlaxton. Six months later, they landed at Le Havre in France, were issued equipment at St. Maixent, then moved on to Amanty, an aerial observation post and the first American field in France near the front lines.

The first big assignment

came with the St. Mihiel offensive. There were 14 planes (DeHavilland 4's with Liberty motors), 16 pilots and nine observers to gather information of enemy movements, act as infantry patrol contacts, probe out the location of German frontline troops and resume communications when the groundlines were severed.

At the battle's end the 50th had done four days of duty with the loss of one plane and 10 casualties; five killed, three wounded and two prisoners of war. From that time forward until the end of the war, they were involved in the Meuse-Argonne offensive. Afterward they sailed from Marseilles and set up their new home at Scott Field, Ill., in May, 1919. Only three months later, they moved to Langley Field, increased their strength and flourished under a new name, the 50th Squadron (Observation). Eight years later the squadron moved to Brooks Field, Texas, where it became inactive in August, 1927.

Reactivation took place at Luke Field, Hawaii, in 1930, with Capt. Frank Pritchard in command. Busy years of training followed, in which the squadron was again renamed, this time: the 50th Reconnaissance Squadron. On Blitz day in '41, they counted seven killed, 13 wounded, one missing. Since then, "Berry Bombers" have been hitting the Japs wherever and whenever they could do the most damage.

They have bombed innumerable Jap bases thruout the Pacific. Their planes have returned to base with motors gone, rudders snarled, hydraulic systems out, landing gear fouled, ailerons hanging

useless, and guselages shot to hell. They have flown, fought and punished the Nips in every sort of weather the tropics can offer (the tropical weather stock is studded with surprises).

One of their pilots flew his B-17 on a lone photographic mission in the Solomons campaign thru 54 attacking zeros, saw five of them destroyed by his crew and returned to base without a scratch on his plane or crewmen.

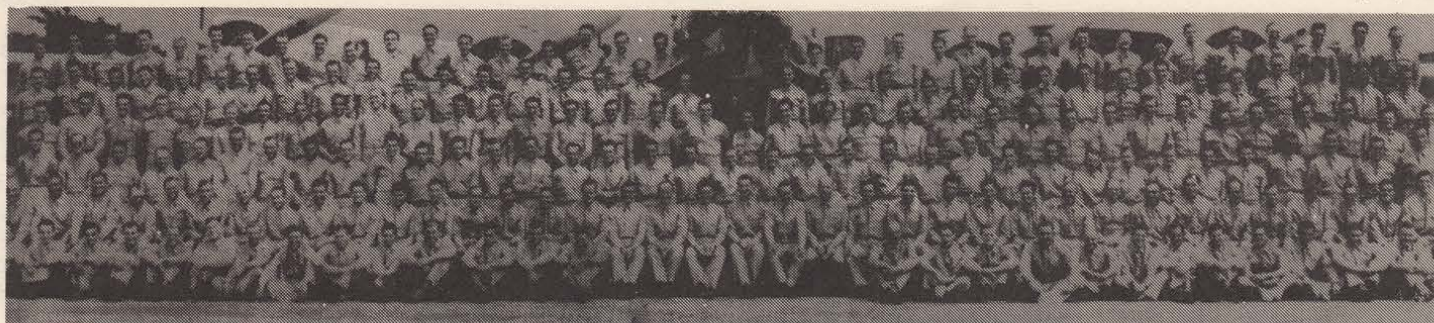
One crewman, Cpl Joseph Hartman, Montgomer, Ala., lived thru the most unbelievable story of the Pacific war. He was a tailgunner on a B-17 when a Zero crashed into his plane just behind the radio compartment during a photographic mission over enemy territory at a height of 17,000 feet.

Hartman was knocked unconscious by the impact and woke up to find himself at what he estimated to be 2000 feet above the water. He bailed out of the escape hatch without having time to fasten his legstraps and when the parachute opened, the extraordinary pressure on his chest put him into another blackout. Again he woke up, this time just over the water, managed to squirm out of his chute harness and dropped into the ocean.

He swam about 150 yards to shore and struggled onto a beach to discover that he was stark naked with no memory of having shucked his heavy flying gear. He finally returned to base after 66 days during which he was listed missing in action and given up for lost.

The events that followed those related above are fully as amazing and, tho the full story is on file, it cannot be revealed due to military information involved.

Shortly thereafter, the squadron returned to Hawaii where its members were dispersed and reassigned to the Mainland. They greeted the Aloha Tower ragged and dirty with worn equipment and a fervent desire for clean sheets and bathtubs. The classic remark of the day recorded in the squadron history book, directed at the veterans who had flown in skies littered with

Jap planes for months on end; and accredited to an MP was: "Wear your gasmasks now, you're in a war zone."

Upon reorganization, B-24's replaced the battered, air-weary Fortresses, new crews flew them and new groundmen took over the maintenance shops. When, some months later, they had finished their training, they embarked for Down Under country and skies in which American planes were gradually evening the odds with Japanese airmen. With an eye on the record set by their predecessors, they have blazed a trail of accomplishments across the Bilberts and Marshalls. Even now, they push deeper into the Carolines and the Marianas, adding in their turn, heroic pages to the squadron history book; but that's another story not yet ready for the historians.

That there's still a long pull ahead, none relize better than the men who fly Berry's Bombers for they have seen the Jap tenacity, have dodged his spreading flak and have spurned his livid tracers past their wingtips. But they mean to see the thing thru and every bomb that leaves their bombays is one more step in that direction.

THE MARINE EMBLEM

Fouled anchors, scarlet plumes, eagles and other insignia were once worn by the U.S. Marines as a mark of identification, and in 1804 a brass hat plate, bearing an eagle, was the current device of the Corps. Early in 1840 officers and enlisted men wore hats adorned with a gold wreath encircling the letters, "U.S.M.", while just before the Civil War this device had evolved into a U.S. Shield, resting in a half-wreath, with the letter "M" placed within the ring of a bugle. Finally, in 1868, came the badge which has marked the Marine Corps up to the present day: the eagle, globe and anchor, shown here. Its designers were guided by tradition in retaining the eagle and anchor, but the addition of the western hemisphere appears to have been an inspiration of the moment. For official use, the Marines' motto, "Semper Fidelis," appears on a streamer above the eagle.

STATE OF ARIZONA HONORS

USS ARIZONA (BB-39)

The USS Arizona's 10-ton anchor and its one-ton chain were salvaged from the sunken ship in Pearl Harbor by the Navy in 1960 and turned over to the State of Arizona in 1972.

A permanent memorial will be constructed this year to rest the anchor and chain near 16th Avenue and Washington in Phoenix.

The plans call for a circular two-level masonry-wall display with the elevated anchor as the focal point.

The USS Arizona was sunk during the attack, and the 1,102 men who died on the ship and are still entombed in it will be honored by the memorial. Plaques bearing the dead servicemen's names are to be displayed on the low masonry-wall around the upper part of the memorial.

A small fountain will provide the environment for the anchor, and some seating will be available for visitors to the memorial, which will be 100 feet long and 60 feet wide.

The Arizona state seal will be laid into the floor of the memorial, and the flags of the United States and Arizona and of the Bicentennial this year, and perhaps the U.S. Navy afterward, will fly from poles at the memorial's west end.

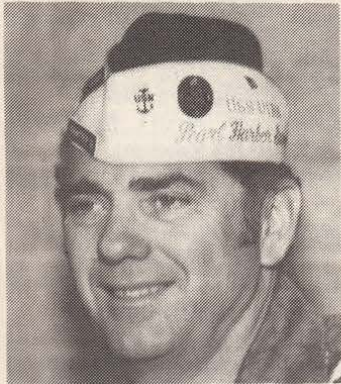
