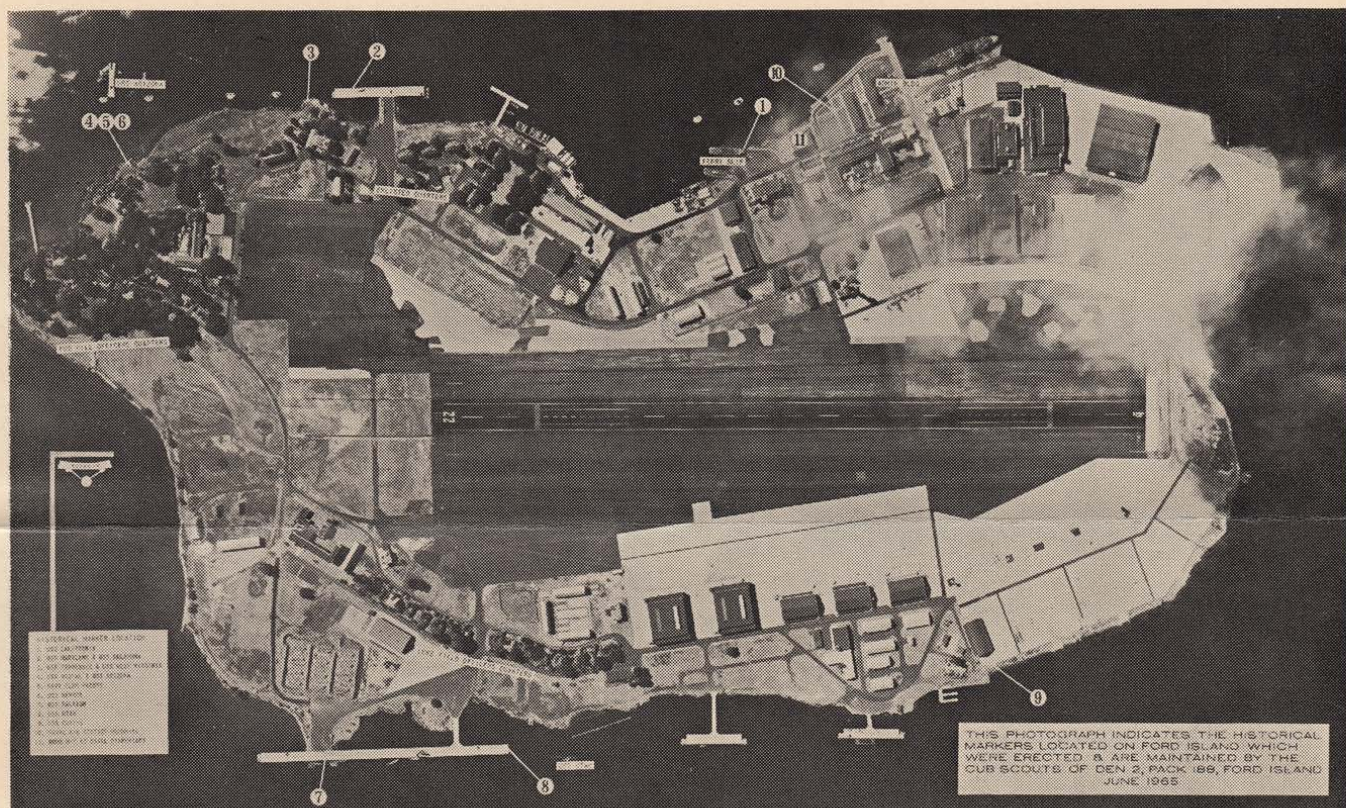

ATTENTION — NON-MEMBERS

We are indeed happy that we are able to mail this issue of the Pearl Harbor-Gram to our non-member friends. As you may already know, the Pearl Harbor Survivors Association was founded in 1958 by 11 Pearl Harbor survivors living in California.

Today we have located nearly 10,000 military survivors of the Pearl Harbor Attack. These thousands live in every state of the Union and many in foreign countries. Our search for survivors continues (note article concerning news release to 15,000 newspapers). Most states have at least one chapter and one state has 7 chapters, these chapters meet at various times. Some monthly, some quarterly, etc., each plays an important role in the National Organization.

The Pearl Harbor Survivors Association National Office is located in the heart of the United States, Jefferson City, Missouri. This office is the hub from which flows a mass of material. Information on all survivors located, member and non-members alike, are recorded on IBM punch cards, these cards are processed thru high speed modern data processing equipment. As an example, the labels used in this mailing were prepared on a printer at a printing speed of 600 lines

per minute, the unit list of members and the state and master alphabetical listing of both members and non-members are prepared at the same speed. The walls of the National office contains 40 pictures of the attack on Pearl Harbor and other installations, all grim reminders of why the PHSA is in existence. We have a library of 16mm sound films on the attack and at the present we are attempting to enlarge this library. In the near future these films will be available (on loan) to our local chapters. No salaries are paid by the Association to its National officers, the only salaries paid are for secretarial and clerical help in the National office. Everyone who handles the funds of the National office must post a Surety Bond. You will notice that our Association has qualified for a "Non-Profit Organization" postal permit under the veteran organization section. The U. S. Treasury Department, Internal Revenue Service has ruled that the PHSA is exempt from Federal Income Tax and that all contributions to the Association are tax deductible by the donor.

We wish it were possible to describe all the many facets of this very exclusive organization and the activities in which we are engaged both at the National, State and the local chapter levels.

It is regreted that our limited funds do not permit us to mail all the issues of the Pearl Harbor-Gram to our non-member friends but we will try to keep in touch with you occasionally.

Due to the huge number of members planning to return to Pearl Harbor with us next year to commemorate the 25th Anniversary of the attack, the workload in the National Office will be extremely heavy and further mailings to non-members cannot be made until 1967. We hope you enjoy reading this issue of our quarterly publication.

The qualifications and costs for membership in the Pearl Harbor Survivors Association are found at the bottom of the application enclosed.

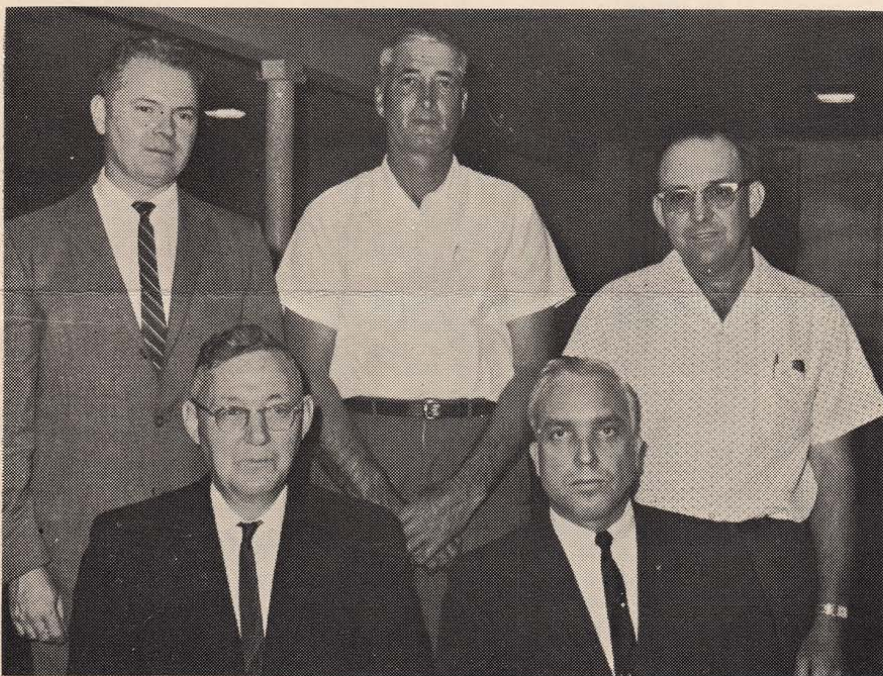
