HAWAIIAN REUNION TO BE NON PROFIT

When the national executive board' met in Clearwater, Florida during the national reunion it was unanimously agreed that no profit should accrue to the national office resulting from the Hawaiian return. It was agreed that after the trip has been made and all of the costs have been determined that any remaining surplus be refunded, on a pro-rata basis, to those who made the trip.

It is impossible at this time to determine the exact cost of this trip due to the many expenses which the national office will incur.

The price of \$289.50 per adult still stands and includes registration fee. In addition to the above, the national executive board discussed the accommodation for those, who for various reasons cannot avail themselves of the services offered by our exclusive travel agency for transportation and hotel facilities. Such members as retired military personnel, those members having friends living in Honolulu and also those employed by airlines, etc. Since it is believed that these members would want to participate in the national activities after they arrive in Honolulu, the following is made available to those who do not travel with the group nor stay in the Sheraton Hawaii hotels.

Round trip transportation to the memorial service, round trip transportation to the individual bases, round trip transportation to the Punch Bowl National Cemetery, Circle Island Tour, Cocktail Party before the banquet, the banquet itself, the Pearl Harbor Tour, the Continental Breakfast, the Aloha Party on arrival and also registration fee. The cost of the above is \$70 per adult. These trips will originate at the Moana Hotel and all must board there. This fee must be paid in full to our official exclusive travel agency, The Fitzpatrick Travel Service, on or before October 21, 1966.

The foregoing price does not include admission to the Champagne Cocktail Party which is sponsored by the Sheraton Hawaii Hotel Corporation for our group since this is for their registered guests only. The national office is charged with the responsibility of co-ordinating many of the activities with the various military commands on the Island of Oahu, therefore, those persons who are not registered with the Fitzpatrick Travel Service prior to departure will not be able to join in the national activities.

Special coupons will be issued for each and every activity except the business meeting and only those persons holding the necessary coupons will be accommodated. Positively no tickets will be sold for individual activities for the reunion in Hawaii and all must be purchased in advance of departure from the mainland.

District of Columbia added to District No. 7.


State Chairman shall serve at the pleasure of the National Executive Board, and he may continue in office regardless of the number of chapters within his state.

From the report this must have been a yery stirring tribute to our Pearl Harbor dead. This 3-day affair is reported as a big success by some very wreary survivors.


ELEVENTH BOMBARDMENT GROUP (H) ASSOCIATION, INC.

HAVE YOU PAID YOUR DUES?
