## VICE PRESIDENT HUMPHREY

### EXPECTED TO BE MEMORIAL SPEAKER

The Honorable Hubert Humphrey, Vice President of the United States, is seriously considering being our memorial speaker at the service commencing at 0755 December 7, 1966 at the National Memorial Cemetery of the Pacific (Punchbowl). We have been in contact with the Vice President's Office for over a year. However, due to the world situation, he is unable to make a firm commitment this far in advance. I am sure all of our members understand his position in this matter.

I was very hopeful of being able to have the memorial services at Pearl Harbor with the USS Arizona Memorial in view since this memorial was dedicated to all of the United States military men who were killed during the attack. However, many problems existed with holding the service there and I am very sorry that they could not be solved. It is this reason that the other site was selected. The National Memorial Cemetery of the Pacific is very beautiful and, of course, it contains the Pacific War Memorial which is a must for all of you to see when you return to Hawaii in December.

Everyone will be scheduled to take the boat tour of Pearl Harbor, which includes the USS Arizona Memorial, and the men who were attached to the naval units in Pearl Harbor or the various base components will also tour this base. Our members who were attached to other military bases will be permitted to tour most of them. However, there are some areas that we are still working on because some of the bases no longer are in existence.

## NOVEMBER 1ST DEADLINE FOR

### DEPOSITS FOR REUNION

At the time of this writing we have reached nearly 2000 persons who have made deposits for their reservations for the Hawaiian reunion. This figure far exceeds anyone's highest expectations and I was recently advised that this is the largest single group ever to go to Hawaii. Due to the many details which must be worked out for everyone who makes this trip, deposits cannot be accepted after November 1, 1966.

"The continued effort of the National Executive Board of the PHSA has finally bloomed out with the fruit of its labors. With the unanimous approval of the Board at Clearwater, Florida, in December 1965, the preparations were begun to assemble into one "Manual" all of the necessary and important administrative functions previously distributed in the form of directives, suggestions, rules and regulations that made the association cohesive and operable across the fifty states of PHSA organization. After eight months of assembling, editing, and preparation for the generalities and specifics that make up the association the total data was printed, placed into a covered booklet, and mailed out to the responsible Officers of PHSA in the National, State and Chapter bodies of PHSA administration. Eighty pages of printed documentary were required to make the manual a satisfactory working tool for the Officers who have been in need of this information in the realm of the PHSA. **GENERAL INFORMATION ON WEARING  
MEDALS, ETC., ON CIVILIAN CLOTHES**

The following is taken from the United States Navy Uniform Regulations, 1959.

**Wearing Of Awards On Civilian Clothes**

1. Miniature medals may be worn with civilian evening dress (white tie) and civilian dinner dress (black tie) in the same manner as prescribed for Evening Dress Blue.

2. The Medal of Honor for which there is no miniature, may be worn with civilian evening dress (white tie) and civilian dinner dress (black tie) in the same manner as prescribed for Evening Dress Blue.

3. Miniature replicas of ribbons made in the form of lapel buttons, or ribbons made in rosette form, may be worn on the left lapel of civilian clothes except civilian evening dress (white tie) and civilian dinner dress (black tie).

4. Miniature Distinguished Marksman-ship and Pistol Shot Badges may be worn as a lapel pin or as part of a tie clasp on civilian clothing by those entitled to the Distinguished Badge.

5. Honorable discharge and service buttons may be worn on the left lapel of civilian clothes except civilian evening dress (white tie).

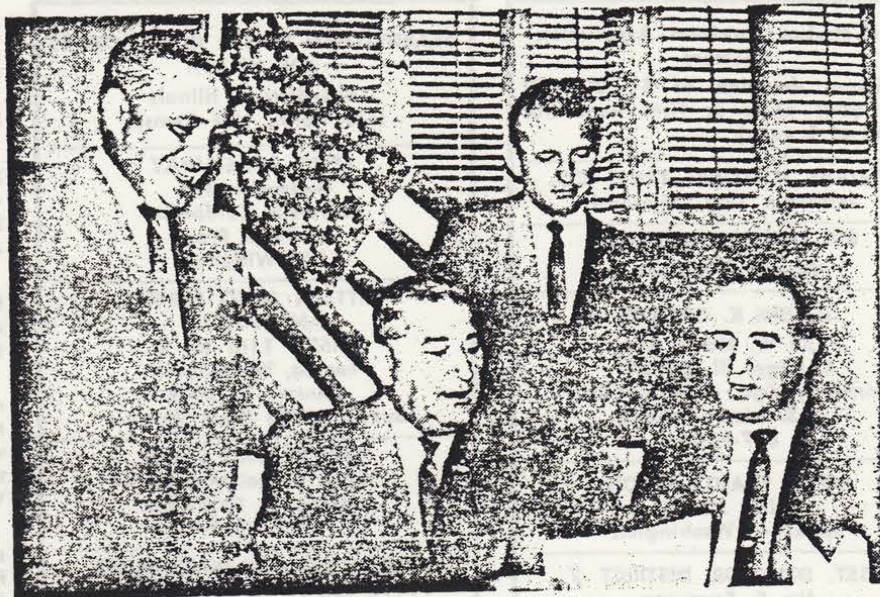
